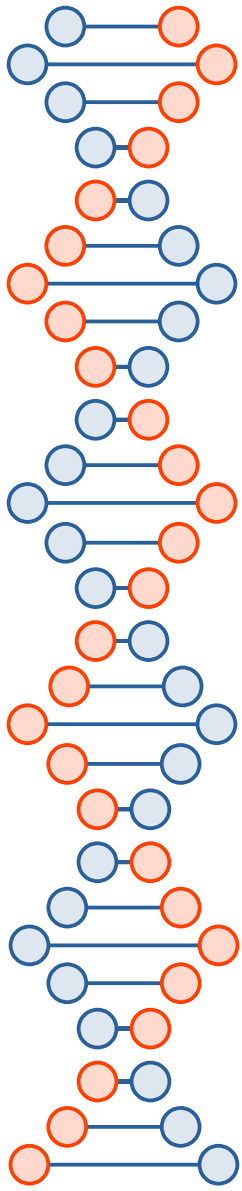
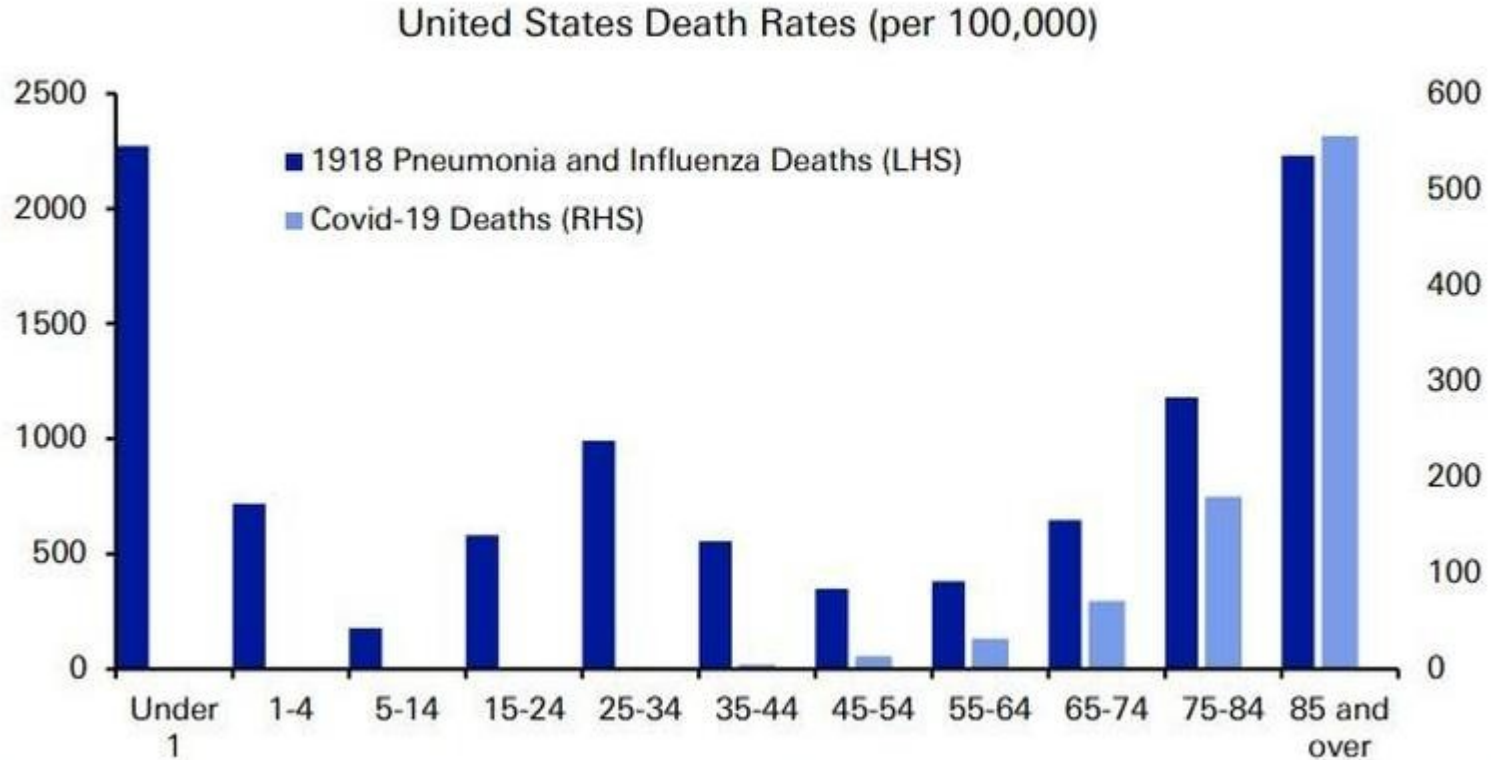
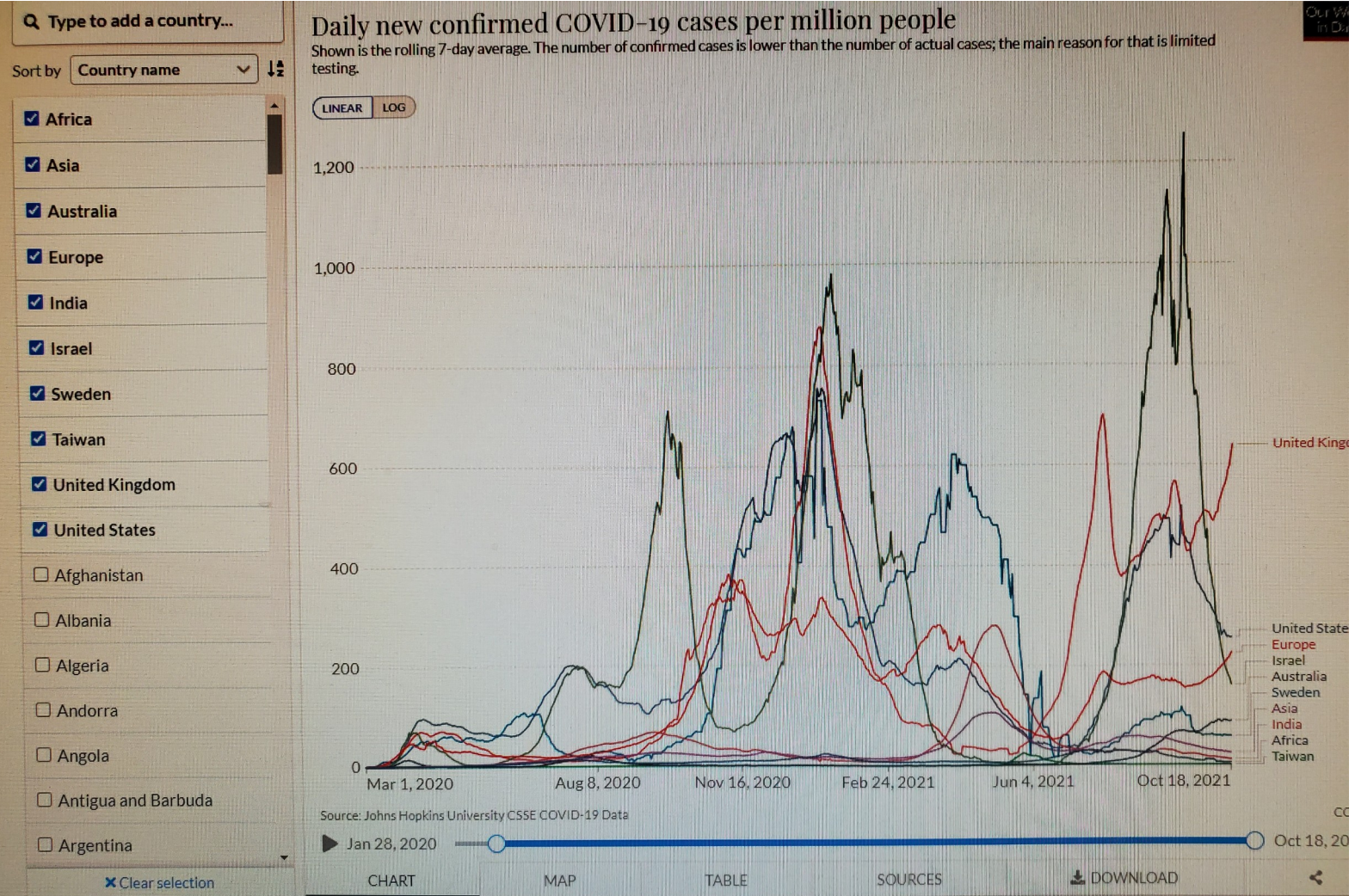
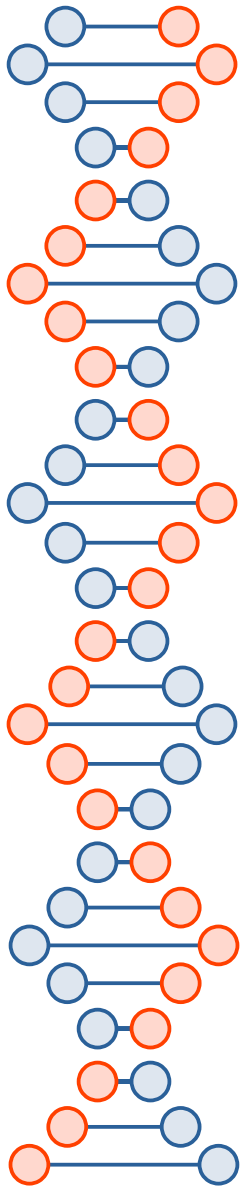


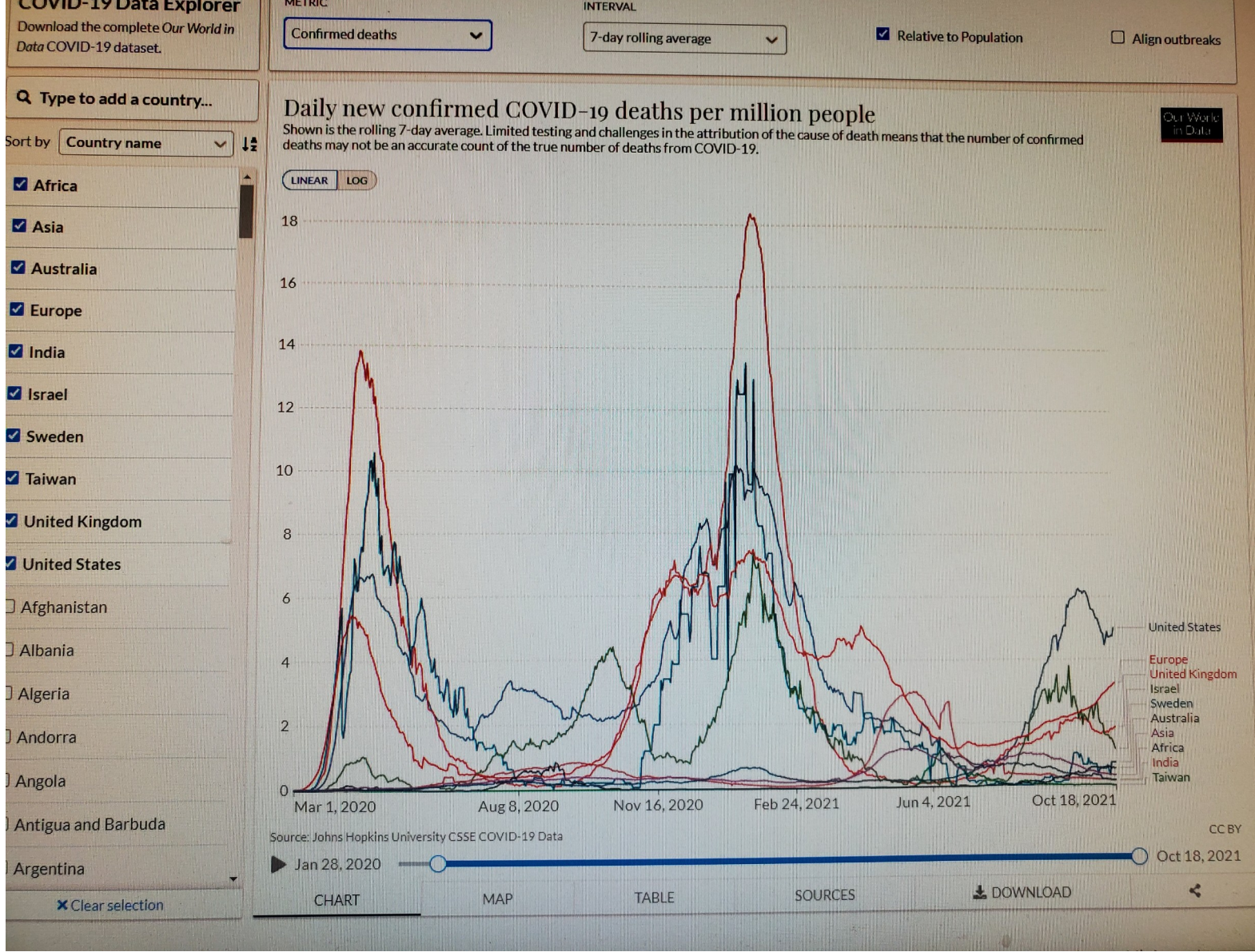
Figure 1: Deaths from Covid-19 have seen a much larger skew by age compared to pneumonia and influenza deaths in 1918 at the time of the Spanish flu

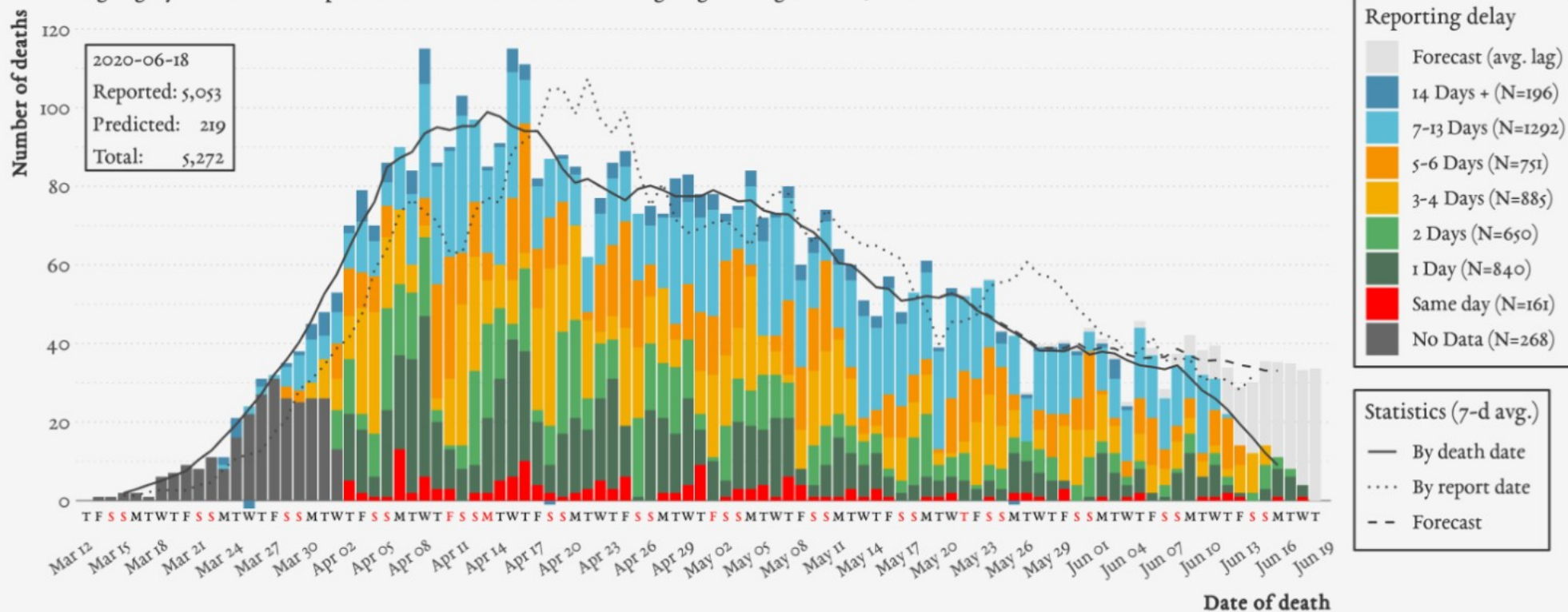






# Confirmed daily Covid-19 deaths in Sweden

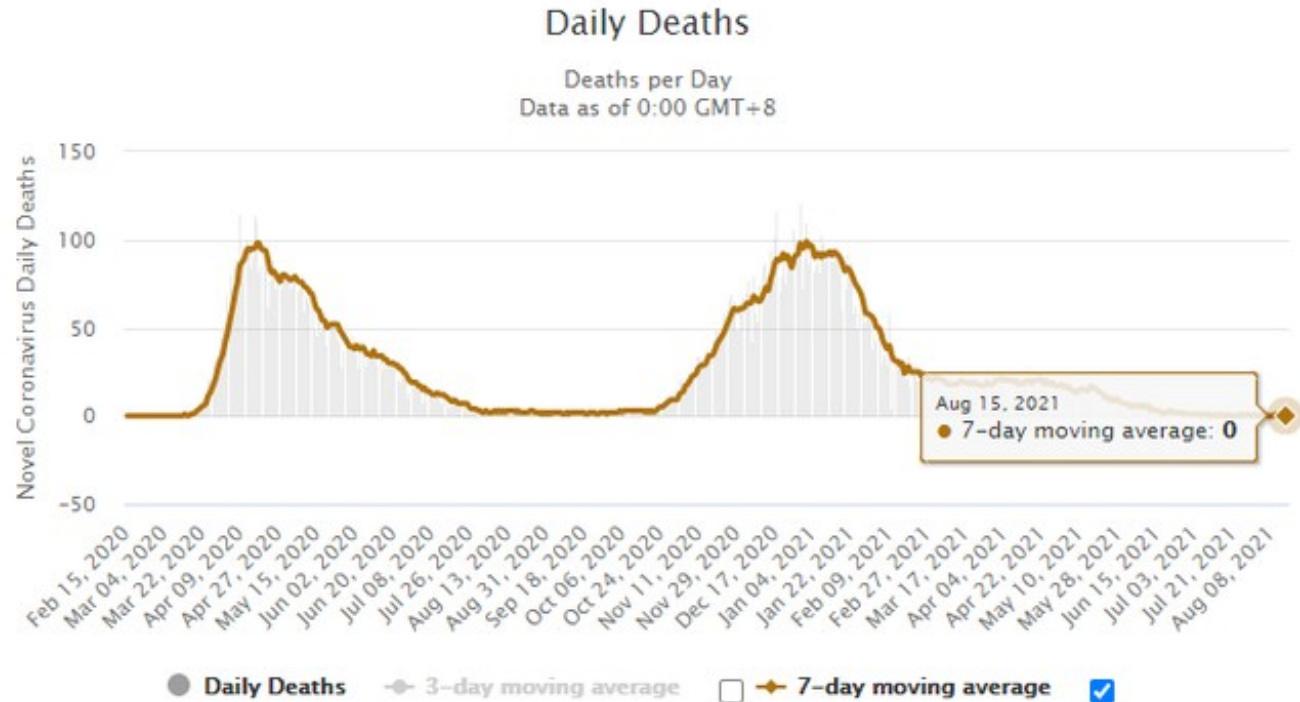

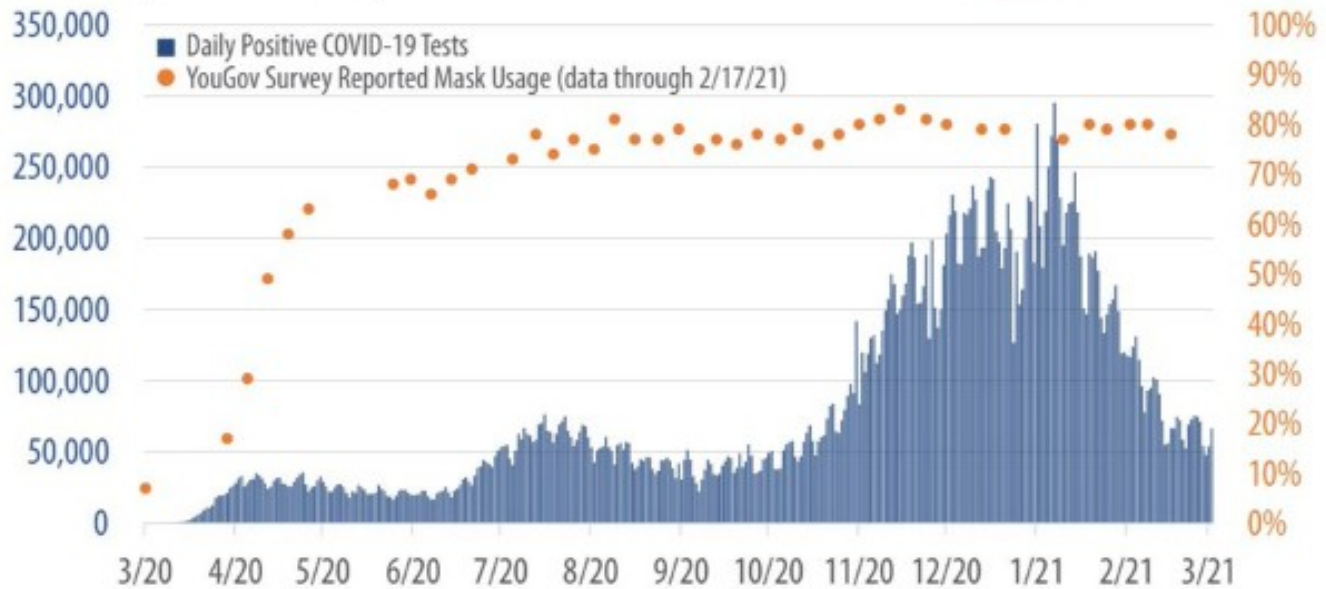




# Mask Usage vs. Daily Positive Tests

March 20, 2020 - March 3, 2021

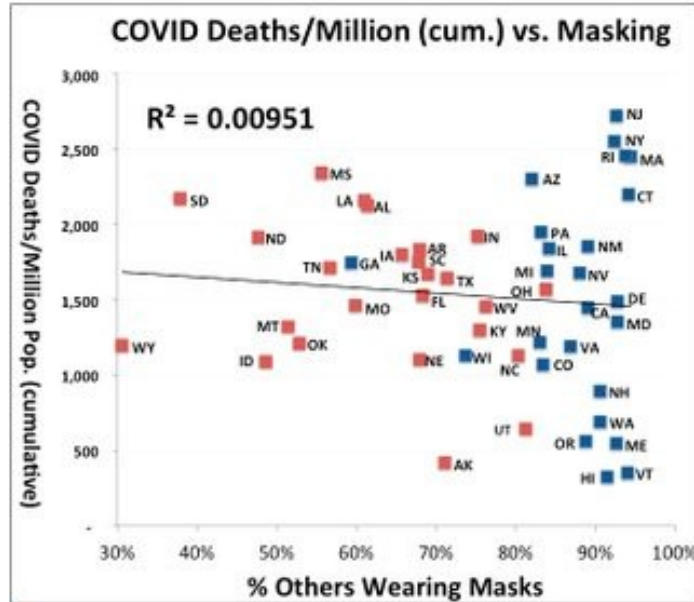

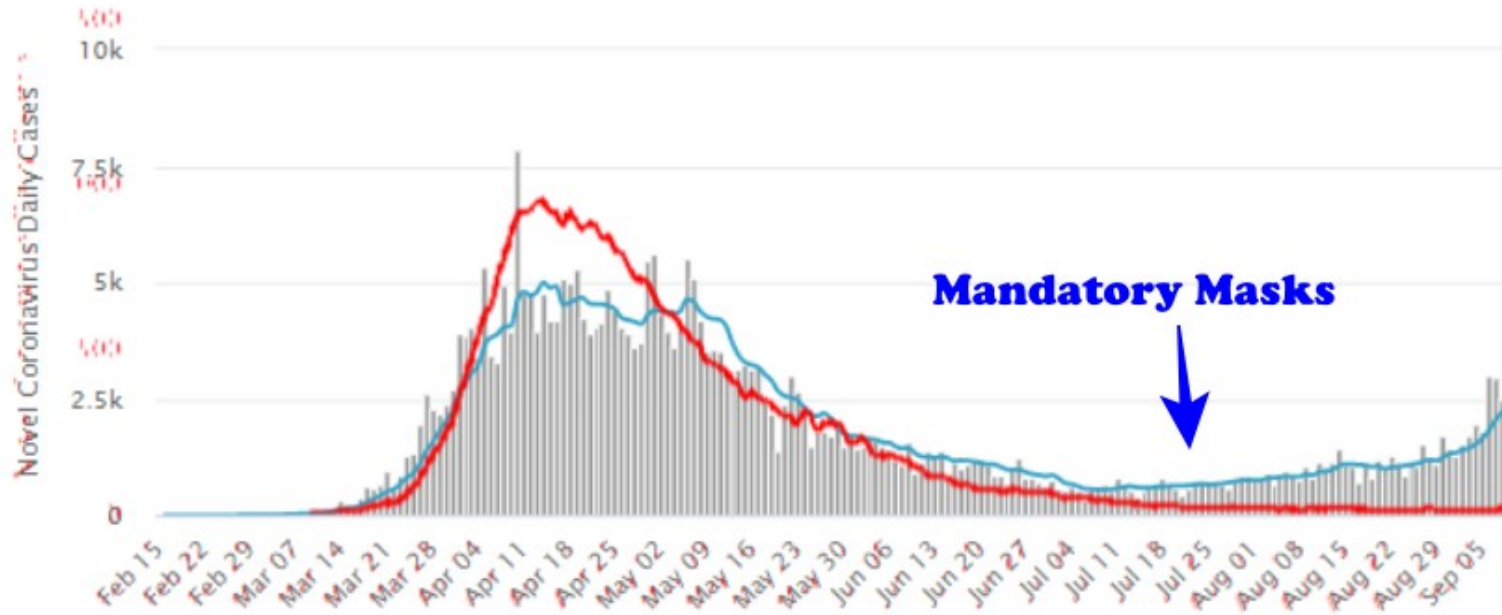

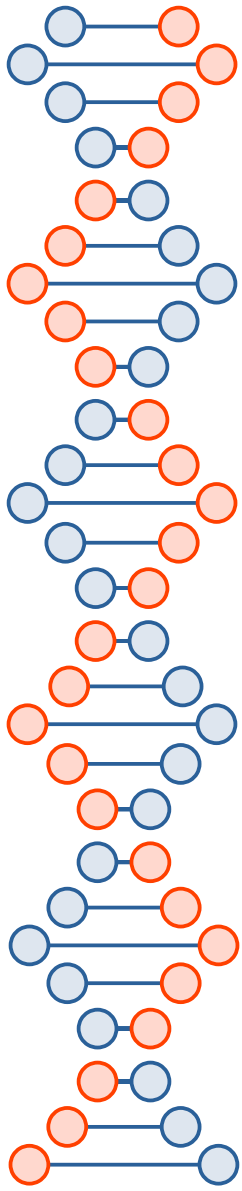

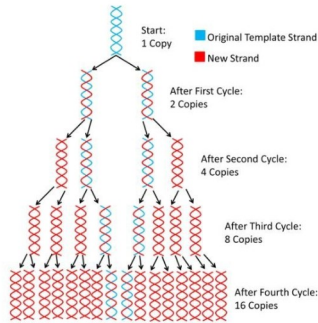

### AMPLIFICATION

This technique involves the amplification\*\* of specific DNA fragments. Only a single DNA fragment is needed to generate **millions, even billions**, copies



### THERMAL CYCLING

A thermal cycler like this, commonly used in a lab to facilitate temperature-sensitive reactions, helps amplify segments of DNA, by increasing and decreasing temperature to specific levels.



### TUBES WITH SAMPLES



The tubes with samples are then placed in the device (similar to the one above) to start the reaction.

A sample consists the following 'ingredients':

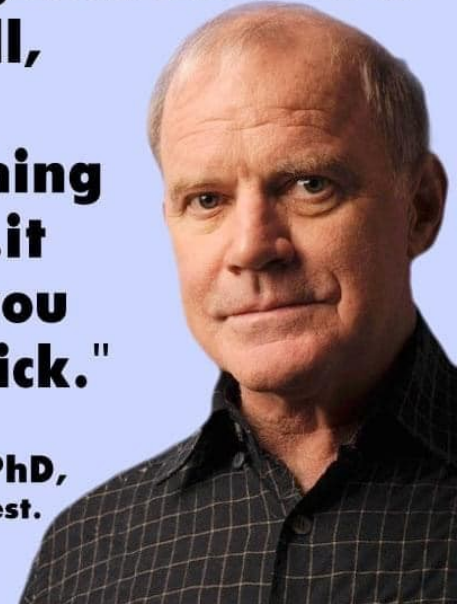
- 10x PCR buffer
- 2mM dNTP mix
- Primer 1
- Primer 2
- Taq DNA polymerase
- 25mM MgCl<sub>2</sub>
- Template DNA

\*\*DNA amplification: The production of multiple (millions to billions) copies of a sequence of DNA.

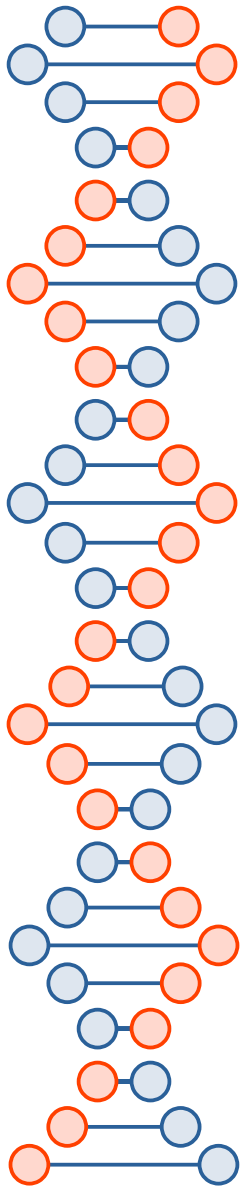

# COVID-19 Vaccine Treatment

- Pfizer Covid-19 mRNA vaccine approved for experimental use (EUA) use in December, 2020
  - Clinical trial to run through to January 2023
- Moderna mRNA vaccine approved for EUA in Jan. 2021
- Johnson & Johnson vaccine approved for EUA in Feb. 2021
- Pfizer Covid-19 vaccine “approved” for full use under the Comirnaty name on August 23, 2021
  - Pfizer EUA extended + Comirnaty Full Use “approved”
- Pfizer booster shot approved for ages 65+ in Sep. 2021
- Other approvals for various age groups pending

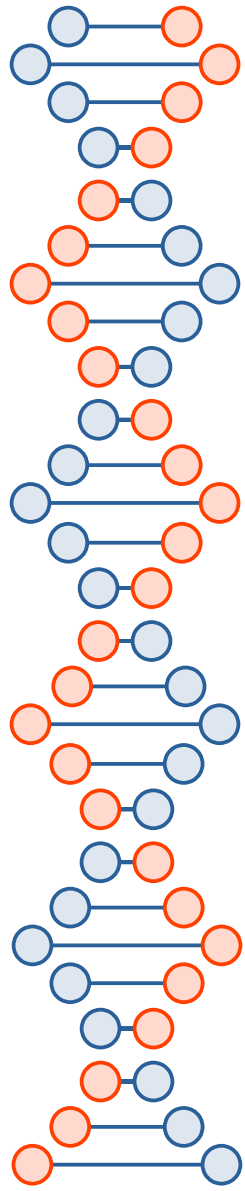

# Some Experimental Covid-19 Vaccine Facts

- Efficacy rates of 90%+, reduced over time
- Minimize symptoms of Covid-19
- Does not stop reinfection or transmission of Covid-19
- Uses new mRNA technology
- Not safety tested on animals
- No long term testing on humans
- Clinical trials incomplete
- Very significant number of deaths and injuries
- Vaccine manufacturers not liable for death or injury
- Infection with Covid-19 → Natural Immunity
- Effective and safe therapeutics are available







# FDA “Approval” of Pfizer Covid Vaccine

- FDA issued two letters on August 23, 2021
  - Extended the EUA for the Pfizer vaccine
  - Granted approval to a different vaccine called Comirnaty which is not yet in the marketplace and is not in production
- Pfizer still has legal immunity under the EUA for all the injuries and deaths caused by its vaccine
- Comirnaty vaccine will not be available until 2024/5?
  - No control group exists
  - It is not yet a vaccine
- “Top scientists [Dr. Peter McCullough + 56 other Doctors] release study warning against COVID-19 vaccines, demand an immediate end to vaccinations”, October 19, 2021



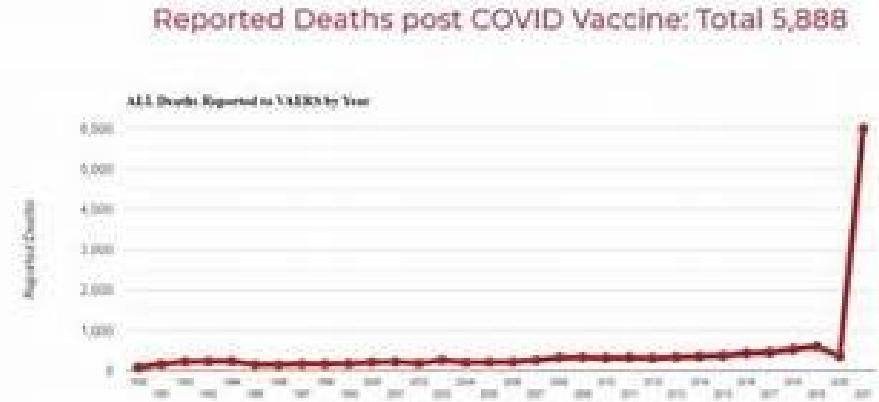
# Pfizer Covid-19 Vaccine Full “Approval” Issues

- Pfizer clinical trials don't end until May 2023
- COVID jab mandates violate fundamental human rights
- There's a history of medical disasters to consider
- There has been no external review of the Pfizer jab
- All we have is six months of incomplete data
- There are no control groups in this global experiment
- The immunity the jabs may have provided appears to be waning
- Pfizer never publicized troubling results from animal trials
- Wave of vaccine mandates issued in response to FDA announcement
- Pfizer is a career criminal with a rising tide of victims



# Children's Health Defense to sue FDA over fraudulent Pfizer covid vaccine “approval”

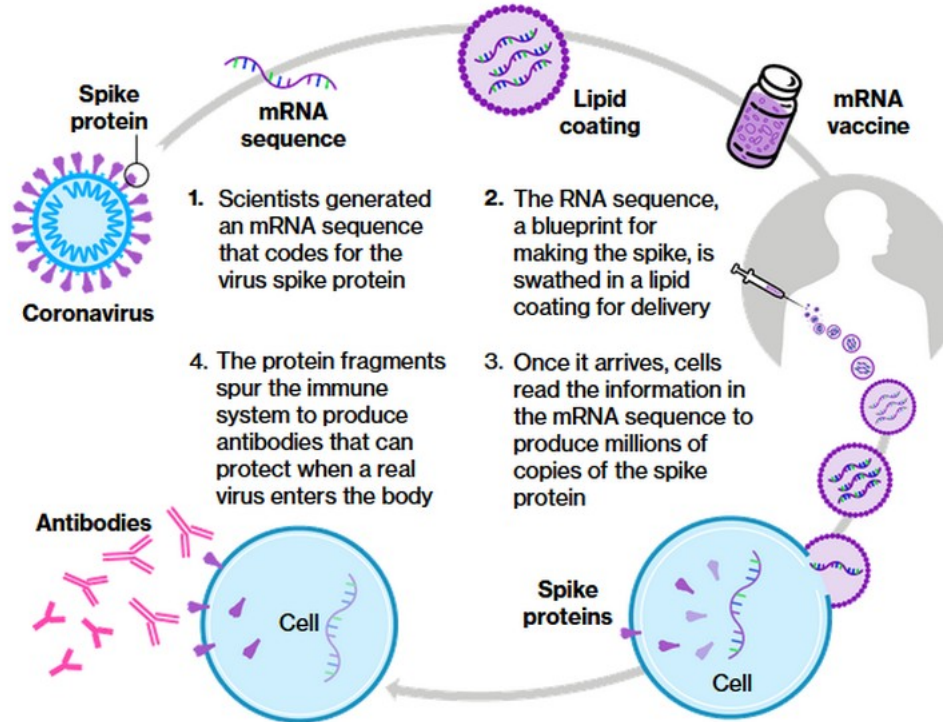
- CHD filed legal challenge on August 27

- 13,000+ reported deaths
- 600,000+ adverse effects
- Less than 50% effective

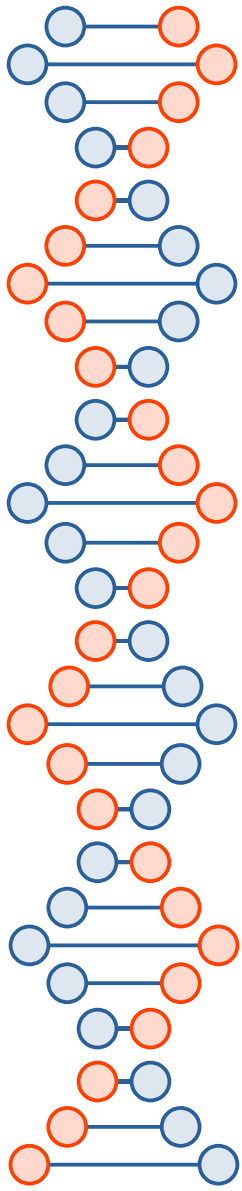
## How mRNA Vaccines Work

The vaccine spurs healthy cells to produce viral proteins that stimulate a potent immune response

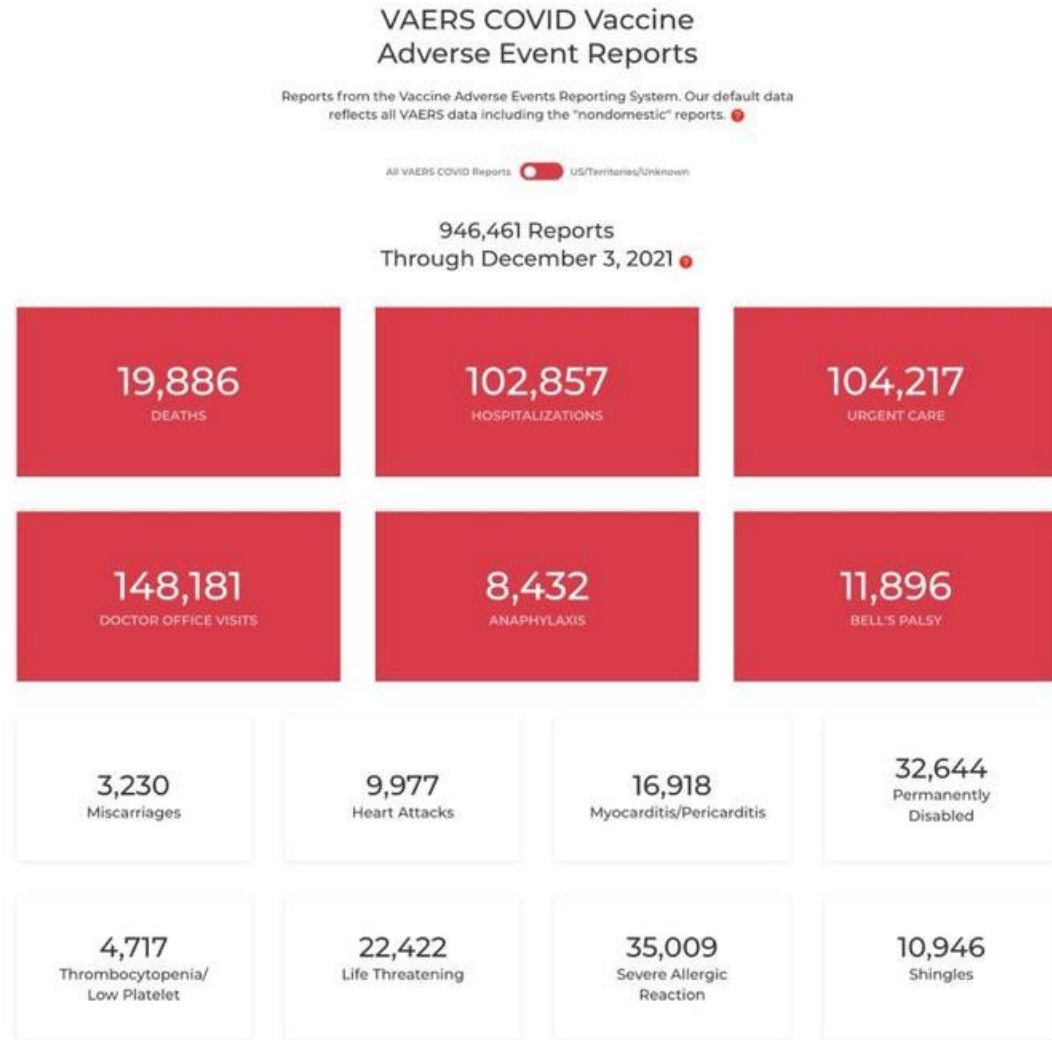

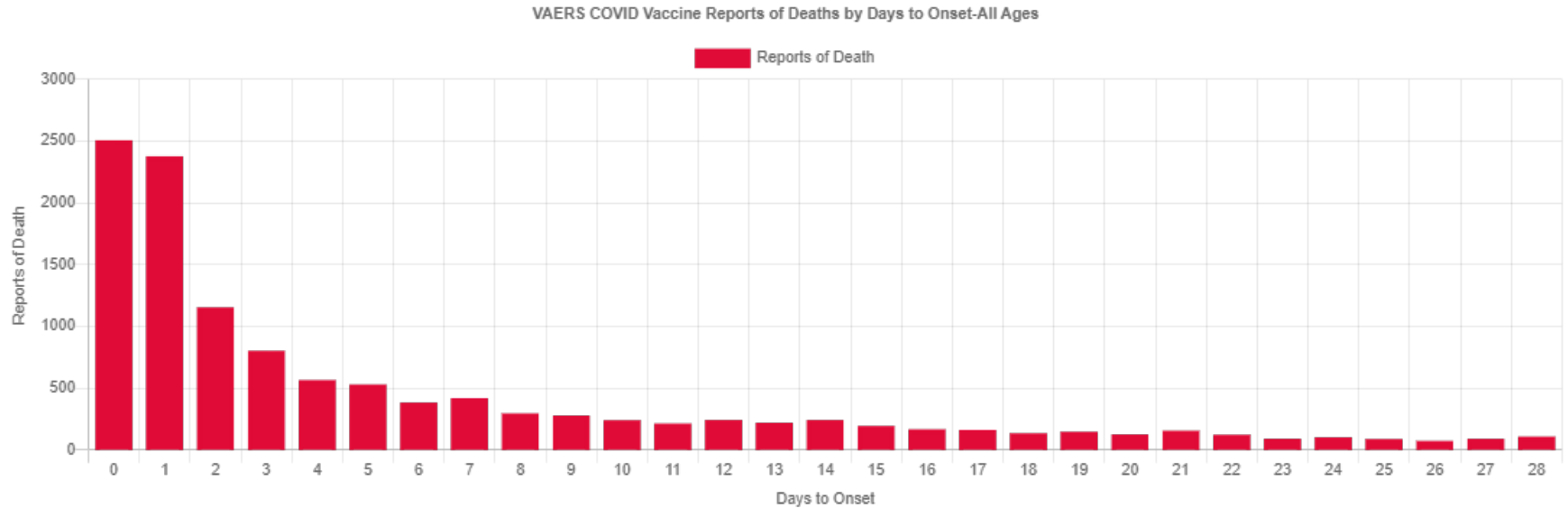

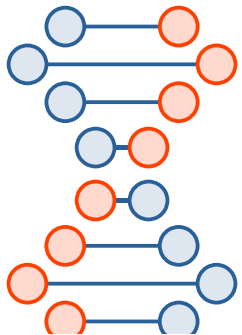
# All Deaths Reported To VAERS by Year

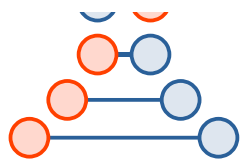

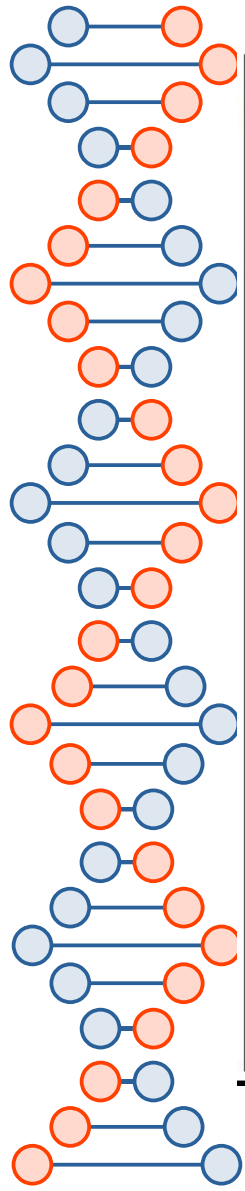

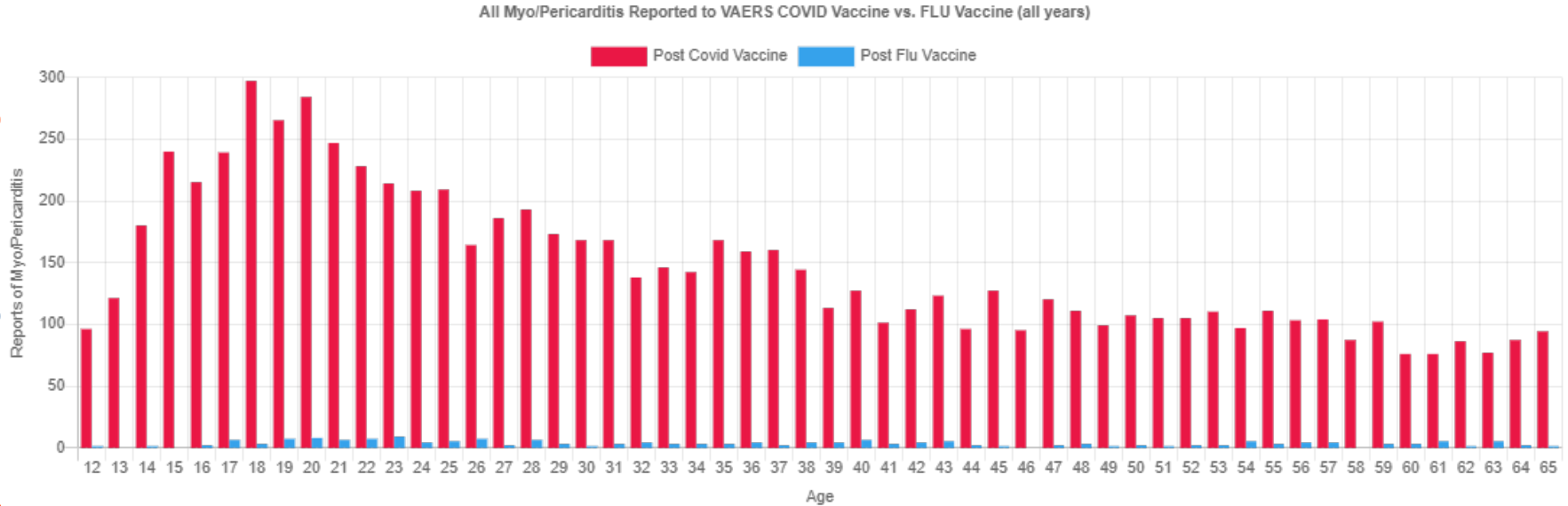

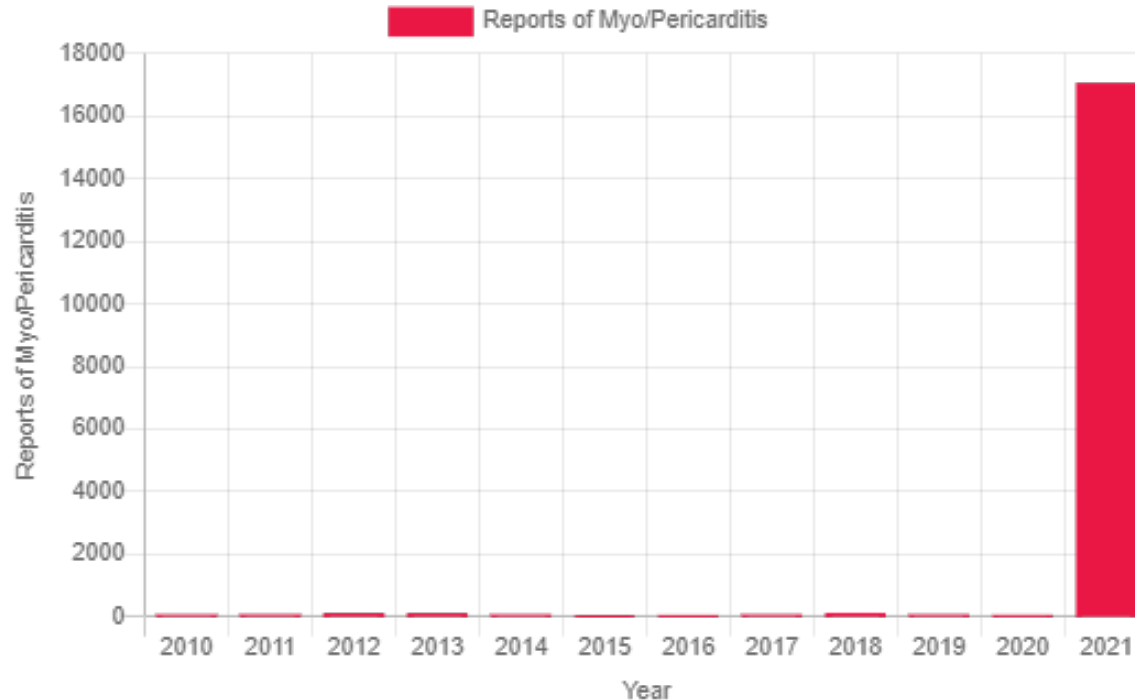


# All Myo/Pericarditis Reported to VAERS COVID Vaccine vs. Flu Vaccine (all years)

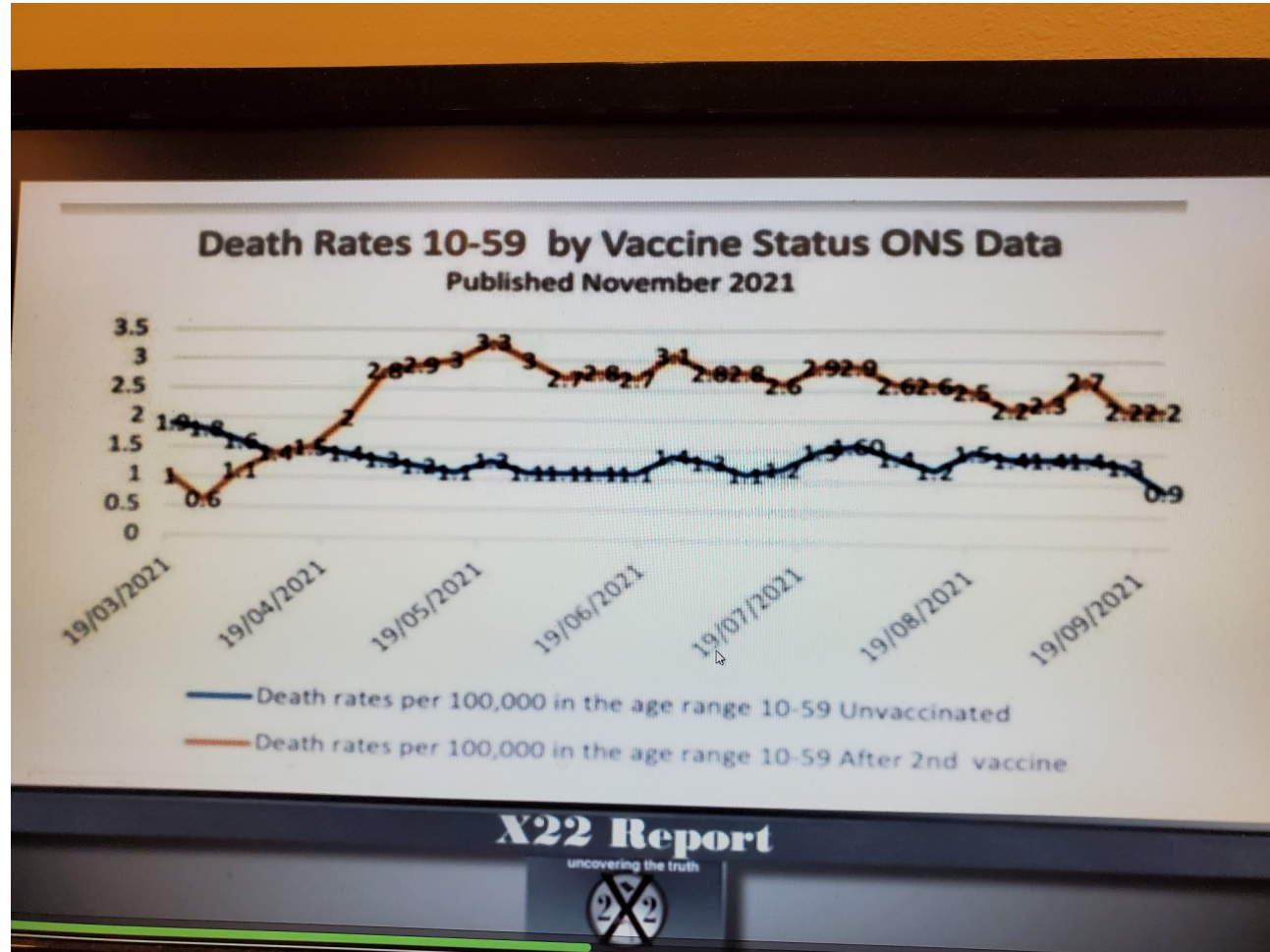

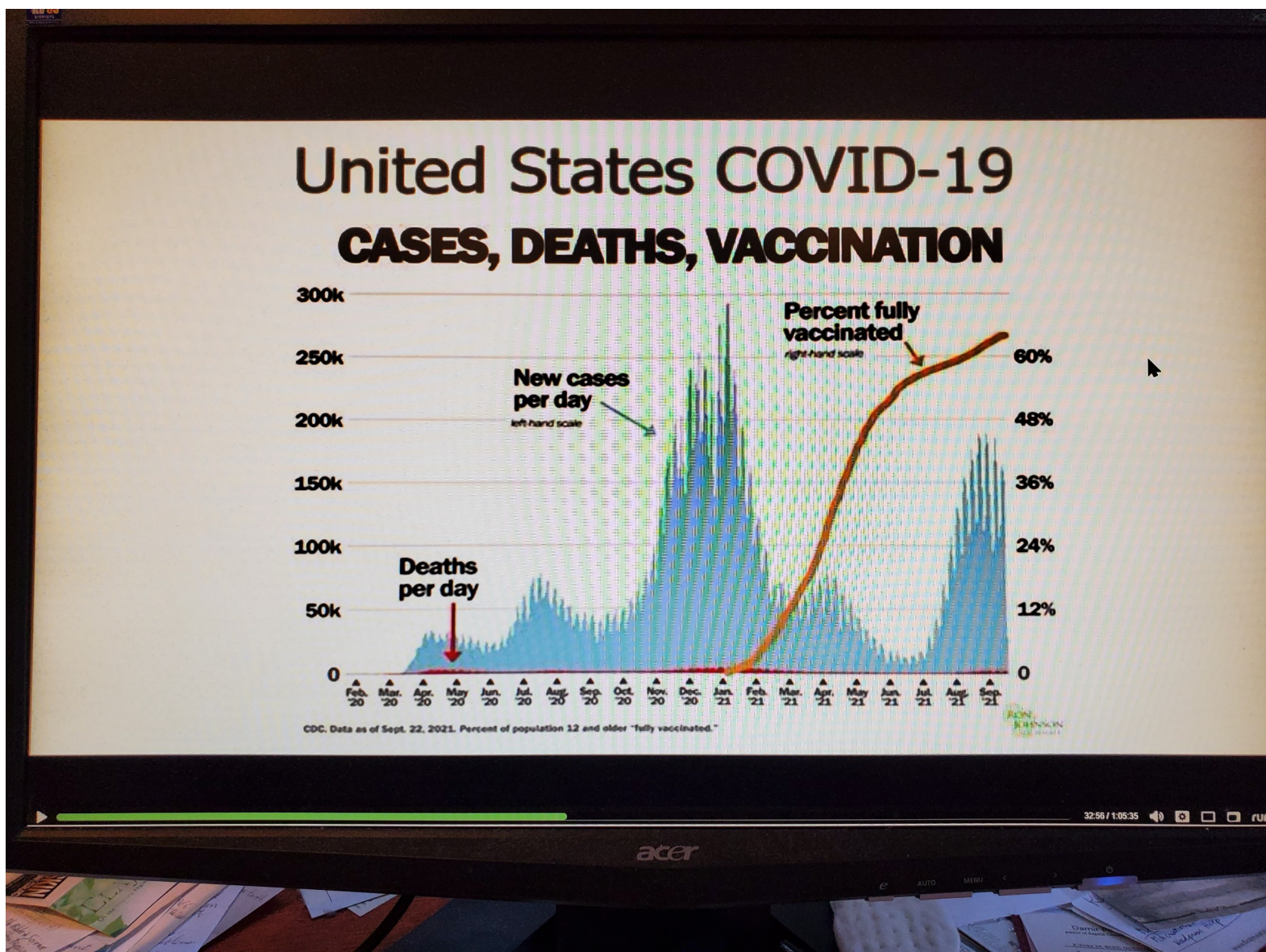

# Death Rates 10-59 by Vaccine Status ONS Data





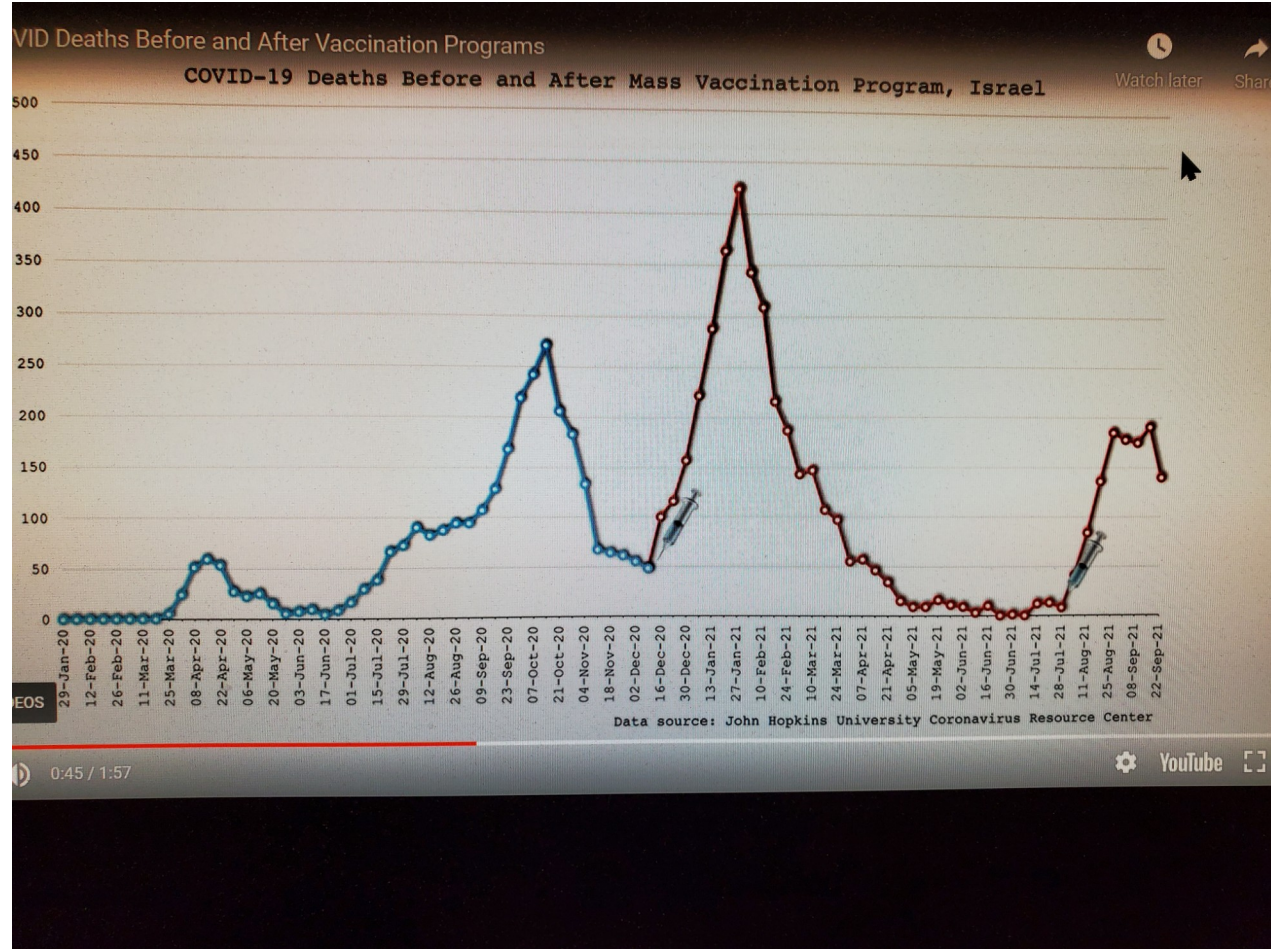


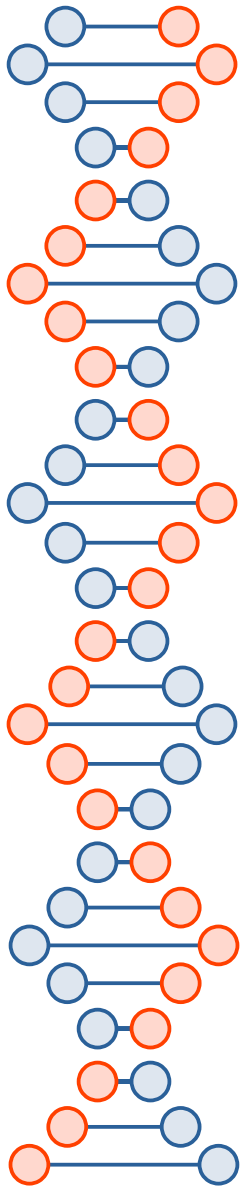






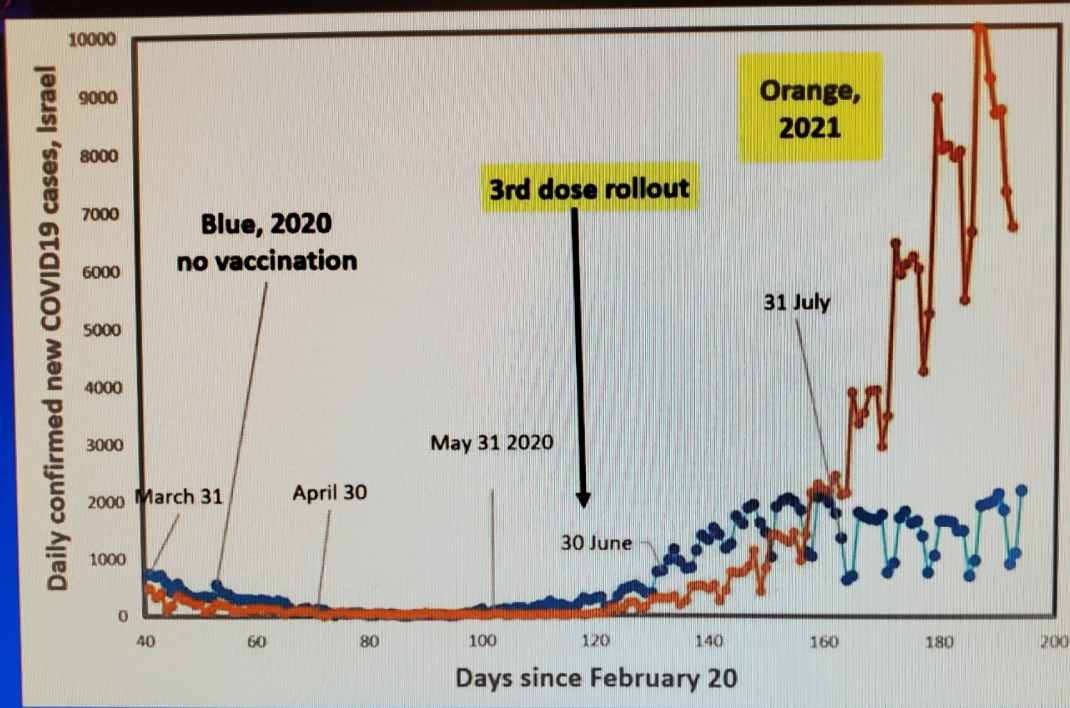

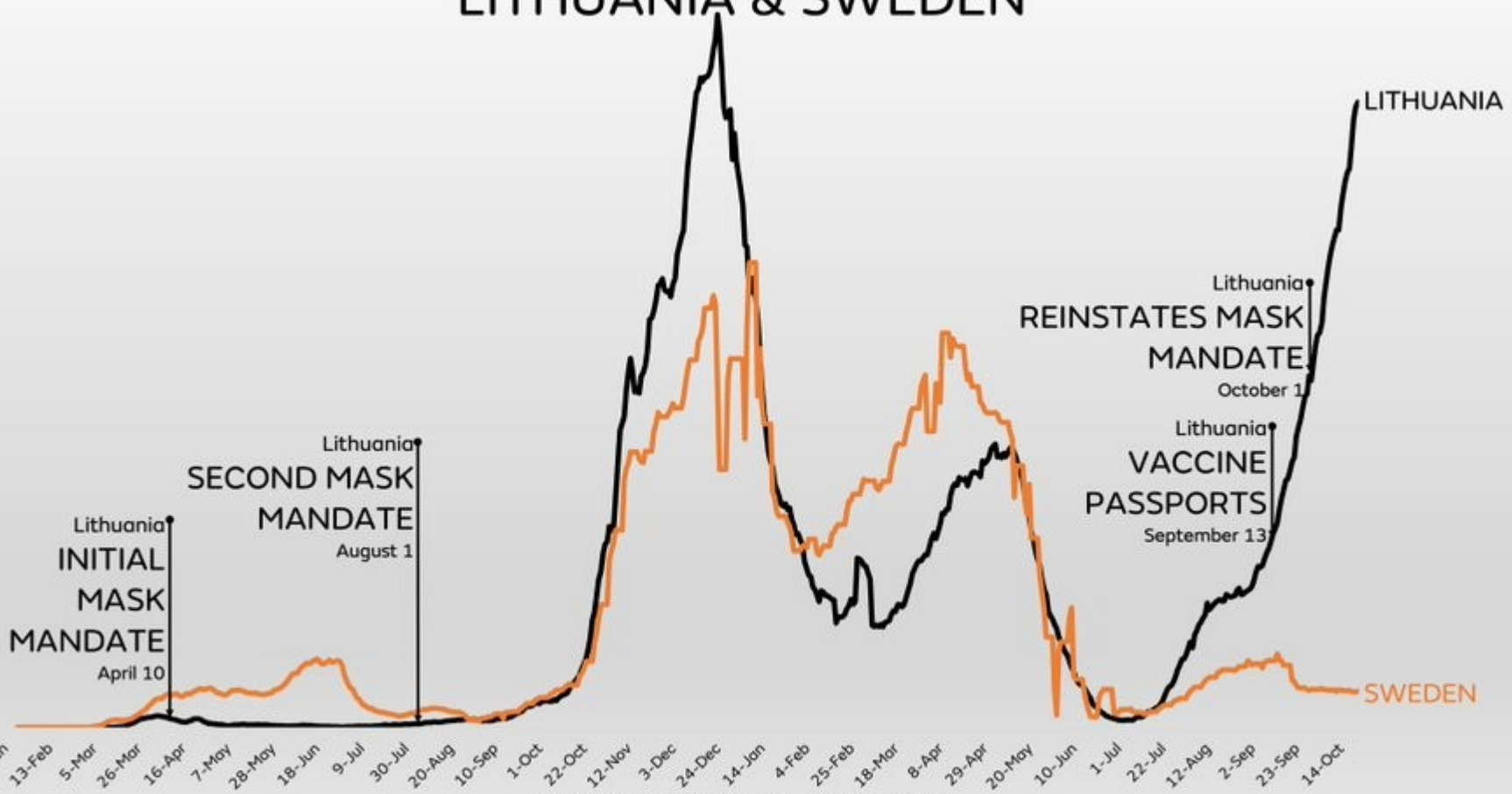

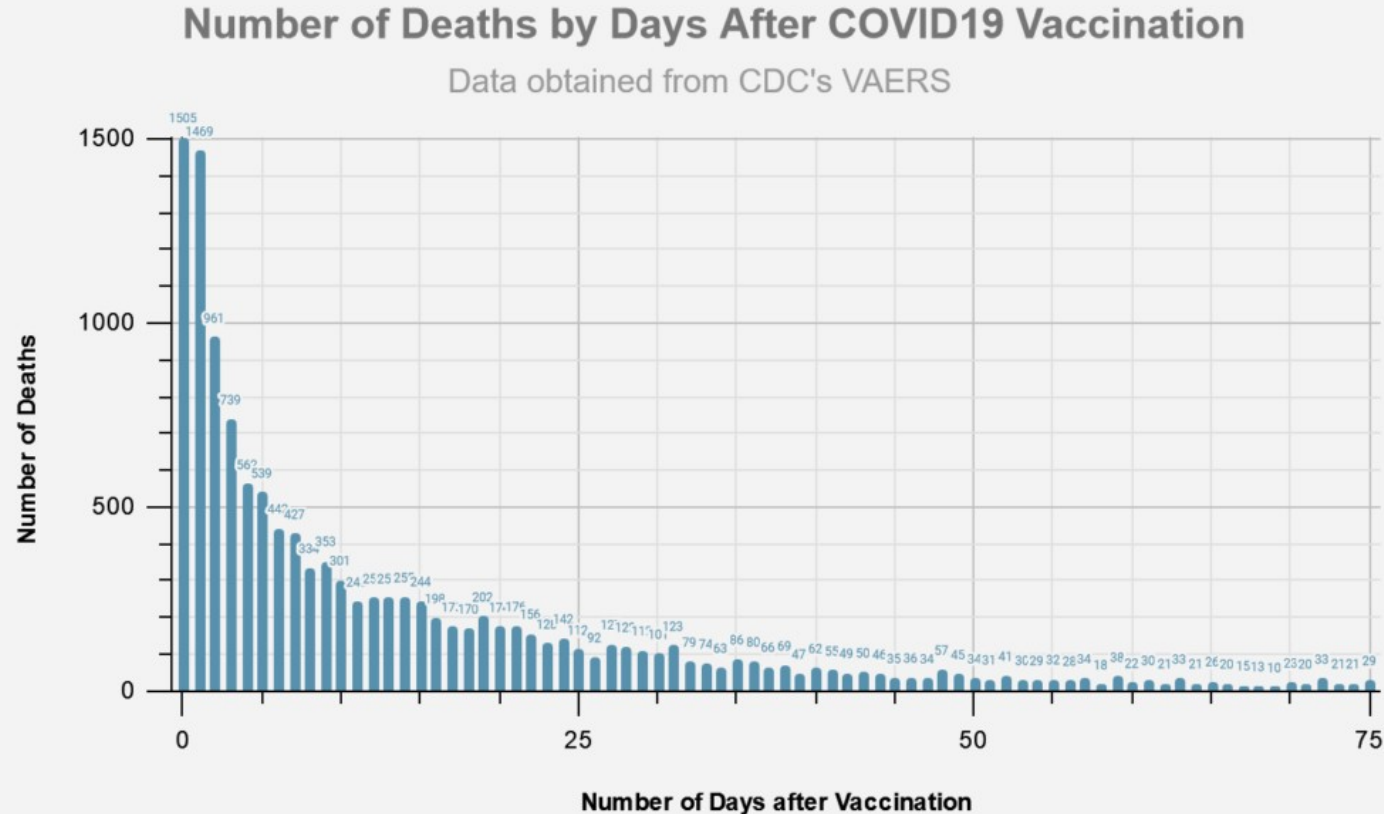

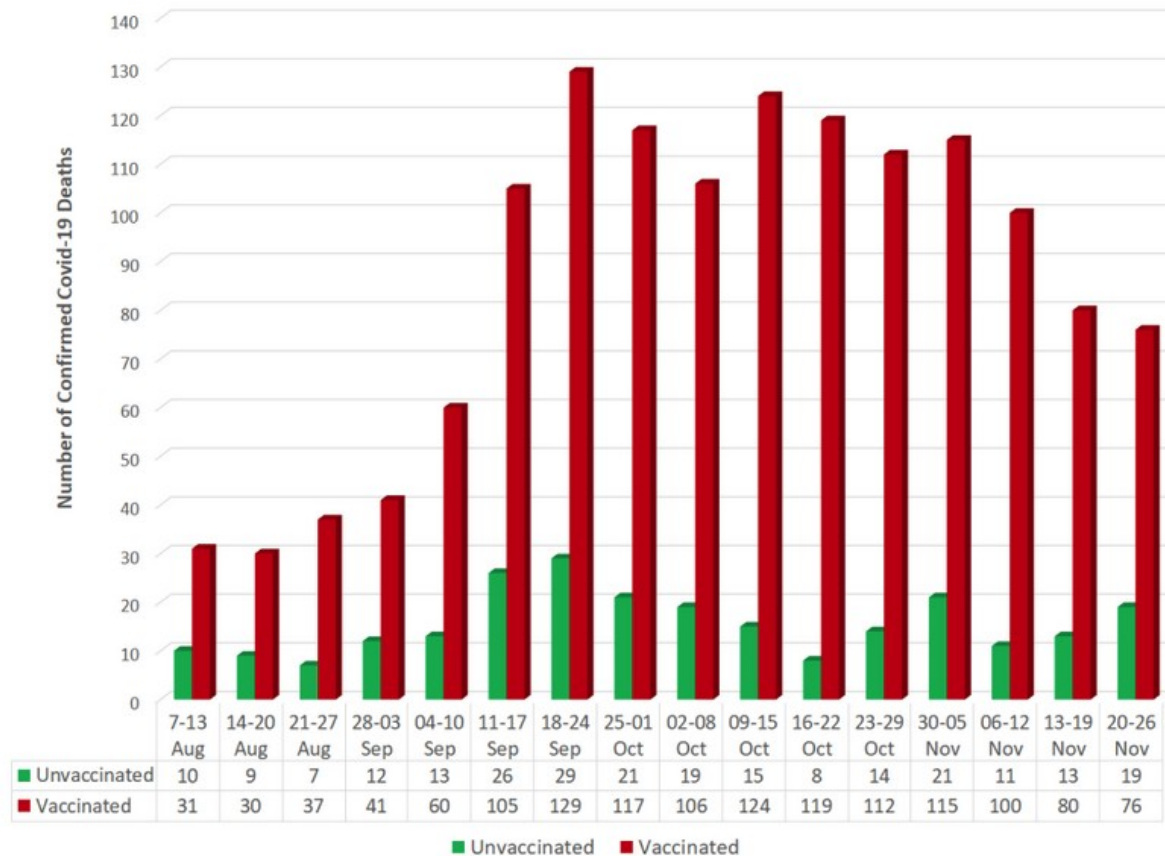

# Number of Deaths by Days After Covid19 Vaccination



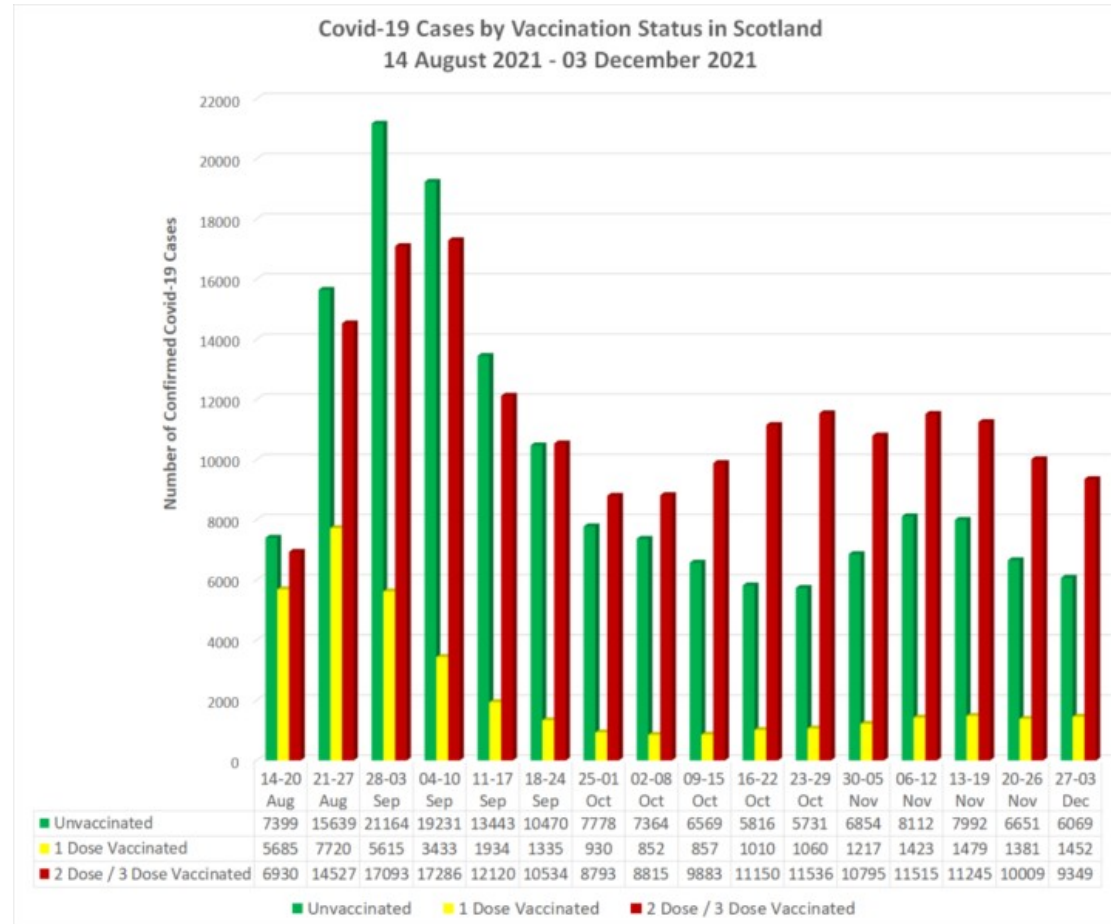

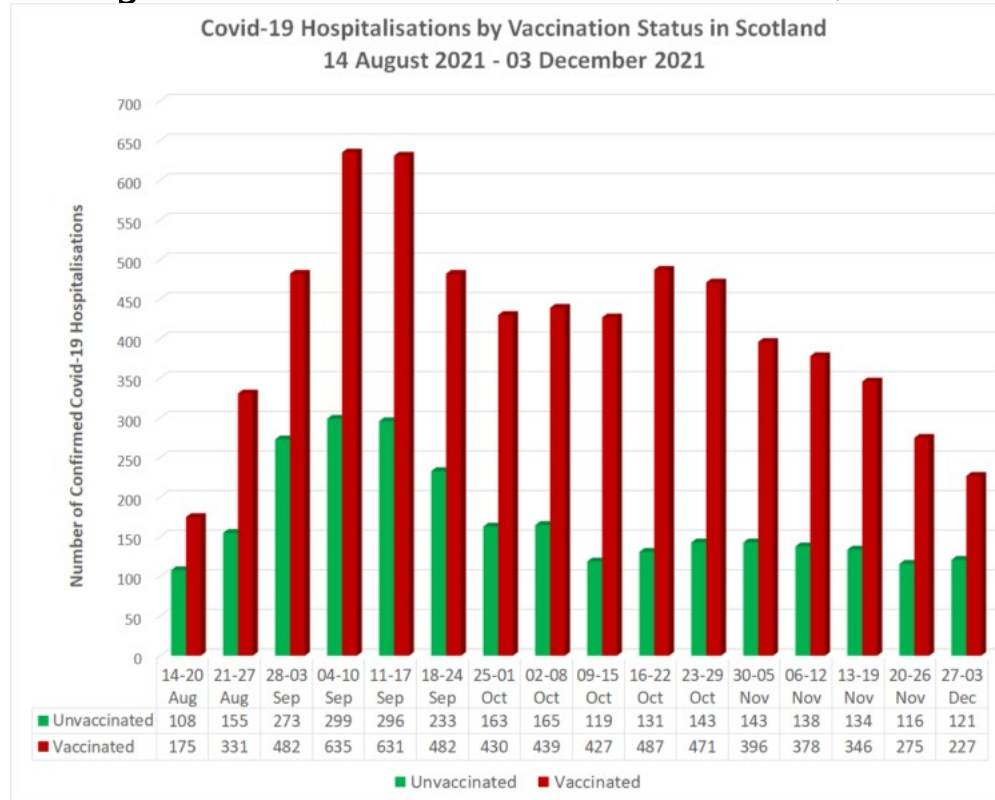




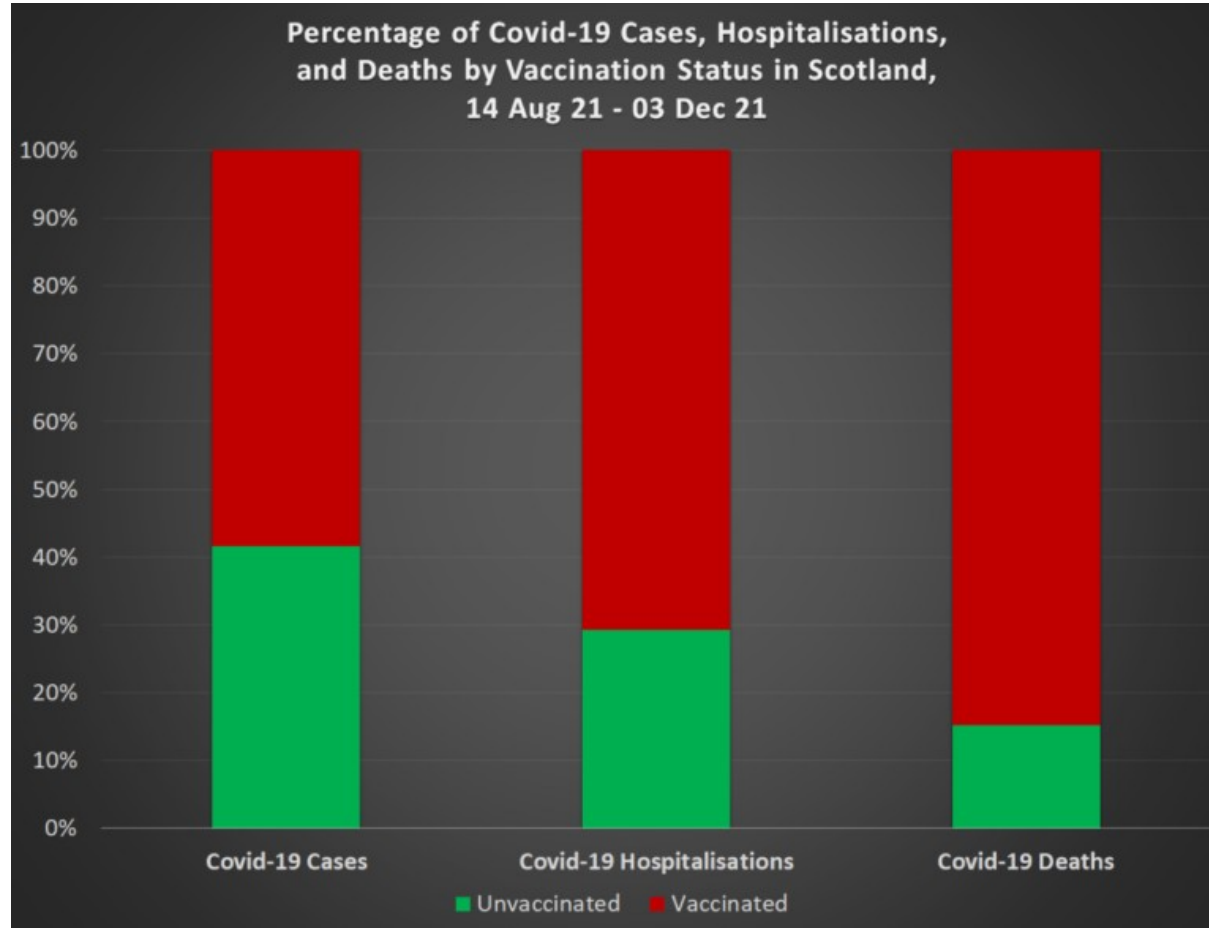
# COVID-19 Cases per Week by Vaccination Status, Scotland

**What is herd immunity?** 


Herd immunity is the indirect protection from an infectious disease that happens when a population is immune either through vaccination or immunity developed through previous infection. This means that even people who haven't been infected, or in whom an infection hasn't triggered an immune response, they are protected because people around them who are immune can act as buffers between them and an infected person. The threshold for establishing herd immunity for COVID-19 is not yet clear.



**What is herd immunity?** 

'Herd immunity', also known as 'population immunity', is a concept used for vaccination, in which a population can be protected from a certain virus if a threshold of vaccination is reached.

Herd immunity is achieved by protecting people from a virus, not by exposing them to it. [Read the Director-General's 12 October media briefing speech](#) for more detail.






# Immunity → Protection

**Vaccination (pre-2015):** Injection of a killed or weakened infectious organism in order to prevent the disease.

**Vaccination (2015–2021):** The act of introducing a vaccine into the body to produce immunity to a specific disease.

**Vaccination (Sept 2021):** The act of introducing a vaccine into the body to produce protection from a specific disease.

## Definition of Terms

Let's start by defining several basic terms:

**Immunity:** Protection from an infectious disease. If you are immune to a disease, you can be exposed to it without becoming infected.

**Vaccine:** A product that stimulates a person's immune system to produce immunity to a specific disease, protecting the person from that disease. Vaccines are usually administered through needle injections, but can also be administered by mouth or sprayed into the nose.

**Vaccination:** The act of introducing a vaccine into the body to **produce immunity to a specific disease.**

**Immunization:** A process by which a person becomes protected against a disease through vaccination. This term is often used interchangeably with vaccination or inoculation.

# Defining “Vaccinated”

- **Who is vaccinated?**
  - 2 shots of mRNA (Pfizer, Moderna)
  - 1 shot of Johnson & Johnson
  - 1 or 2 shots + 2 weeks or more [**fully vaccinated**]
  - Resulting in Limited Immunity
- **Who is unvaccinated?**
  - No shots and no Covid infection
  - 1 or 2 shots + less than 2 weeks
  - No shots and recovered from Covid infection, resulting in Natural Immunity



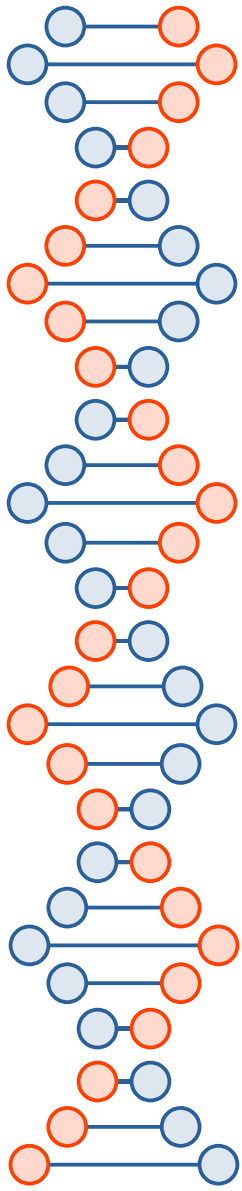

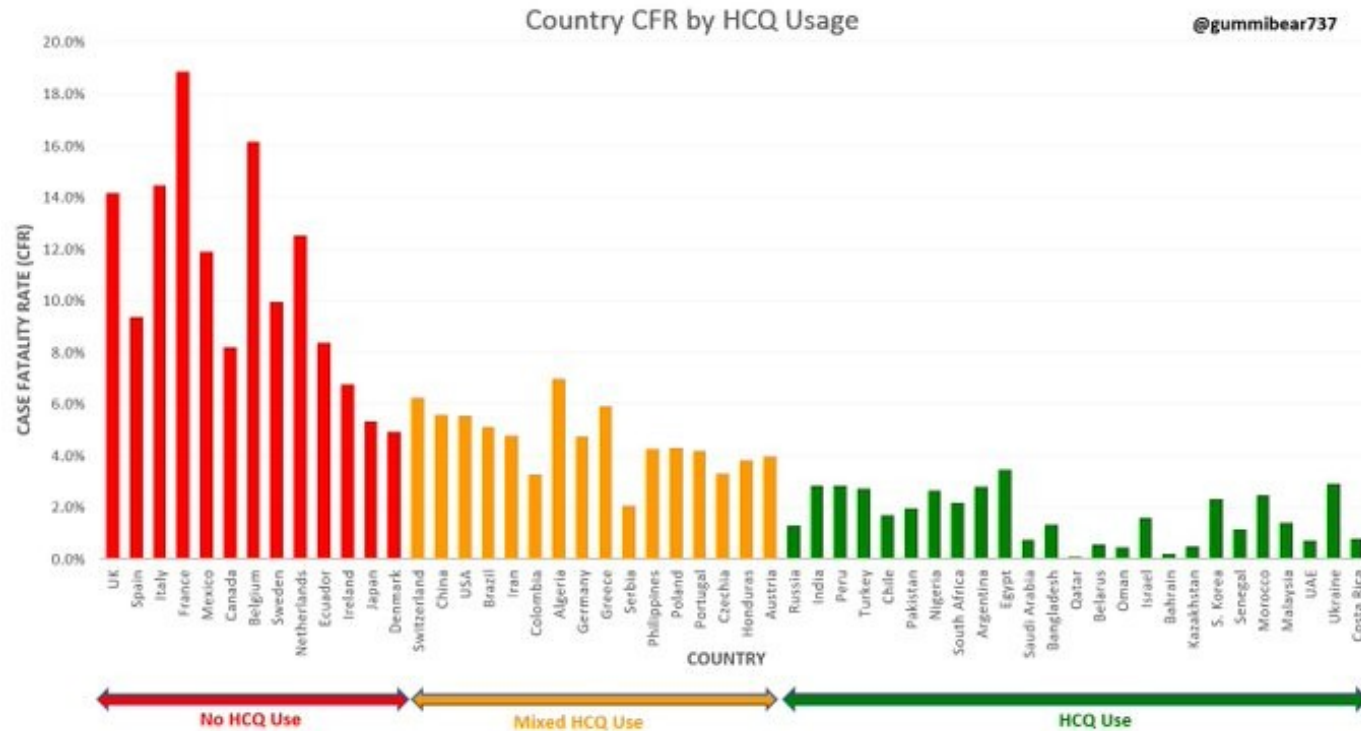

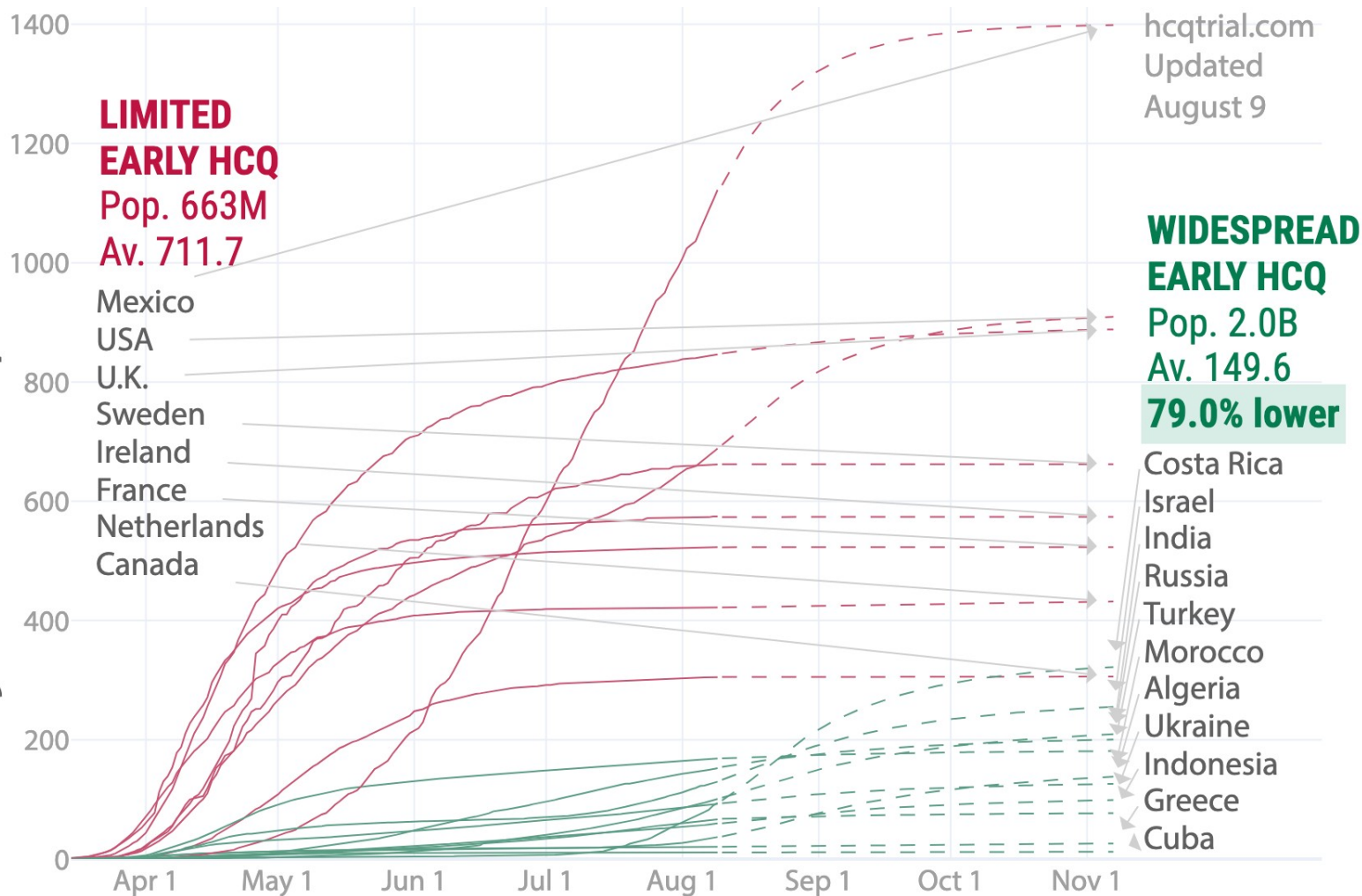

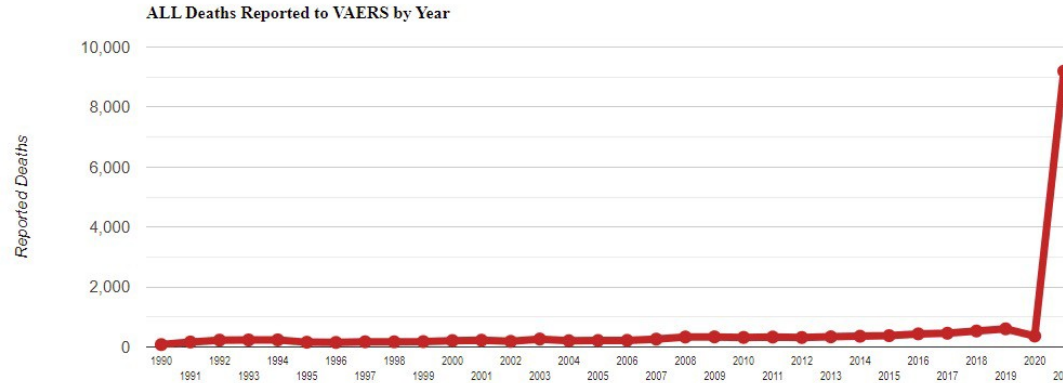

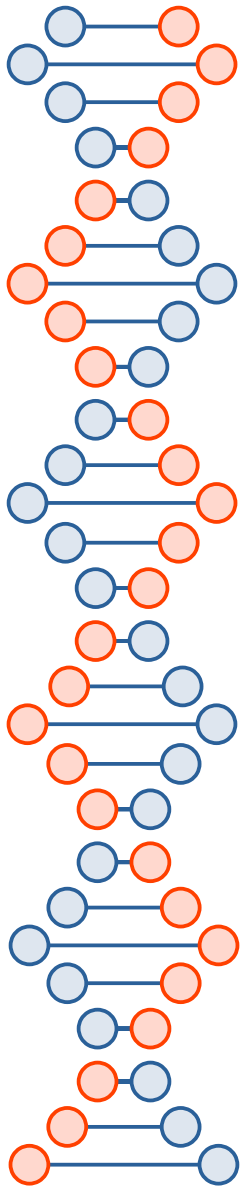

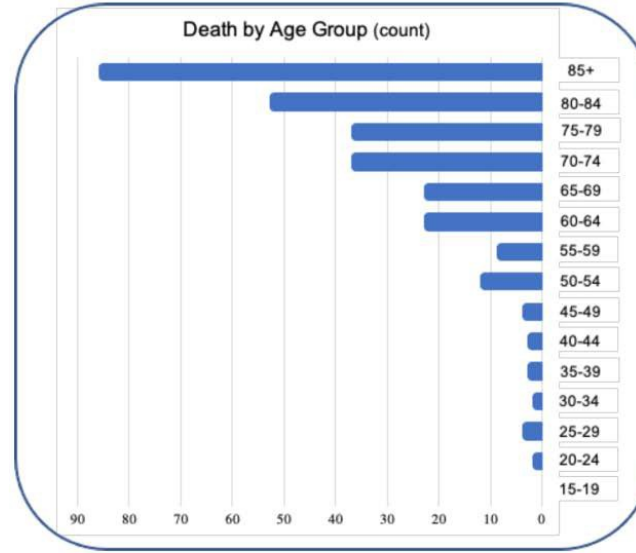
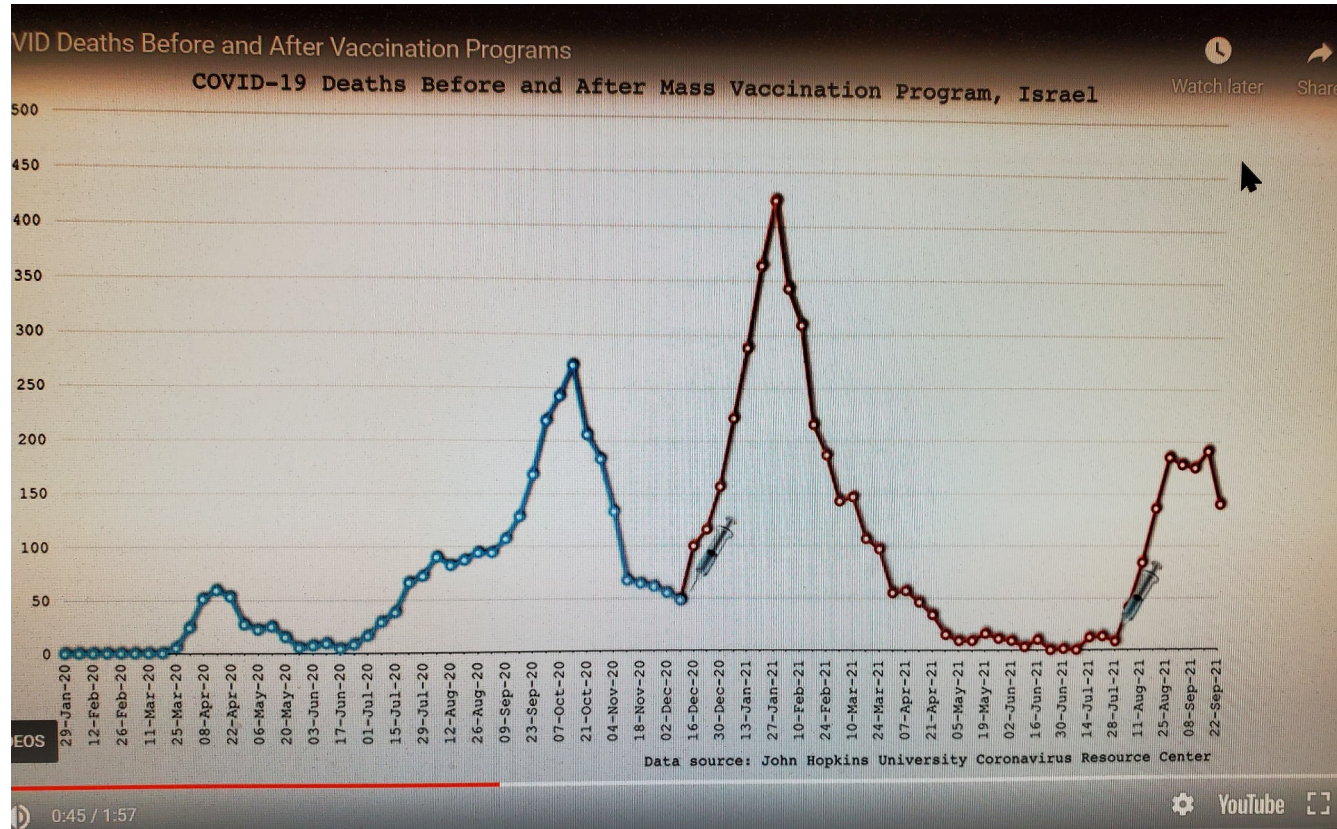


Figure 3: Death by Age Group

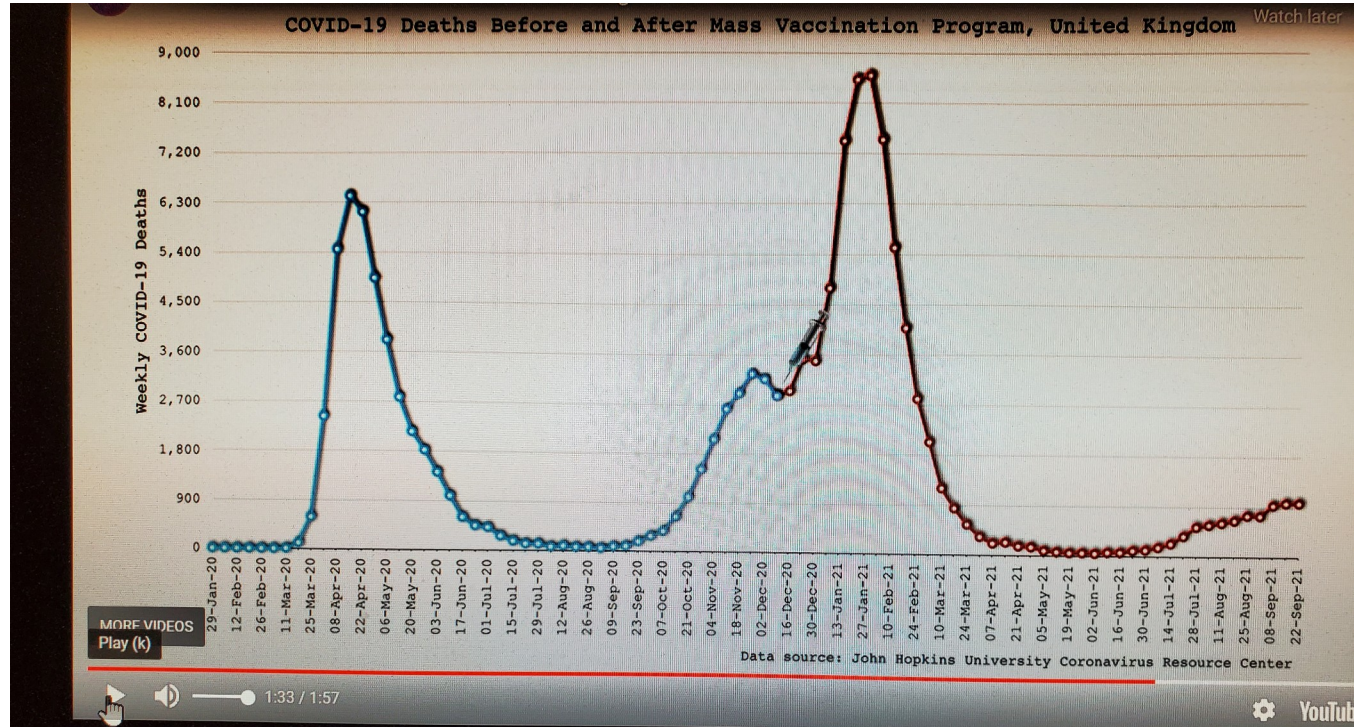

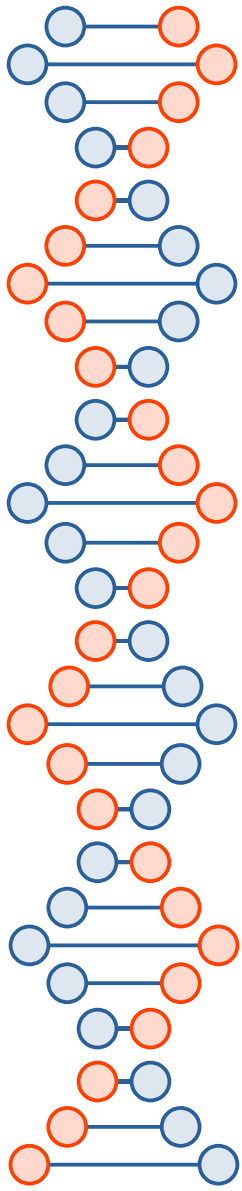

# Peter McCullough: The Vaccine Catastrophe

## Peter McCullough: The Vaccine Catastrophe #2

- None of the public measures (masks, lockdowns etc) are supportable – there is zero benefit.
- Early treatment is key, focusing on those who actually have COVID, not everybody else.
- We now have 13,000 deaths from the vaccines and we've never had a press briefing on safety or efficacy.
- The vaccines cause the body to make spike proteins, and because younger people have more vigorous spike protein production, they are especially damaged with neurologic, cardiac, immunologic and hematologic effects.



## Peter McCullough: The Vaccine Catastrophe #3

- The vaccinated are, it appears, super spreaders, carrying large amounts of virus and passing it to the unvaccinated, creating the delta pandemic.
- I think, honestly, the vaccine programme is a bigger problem than COVID in NZ. If tomorrow the vaccine went away, it would be a national holiday. I can't think of any past drug or injection that is this dangerous.
- We have an out-of-control snowball of biological catastrophe and we're doing it to ourselves at the point of a needle.



## Conclusions of McCullough Reports

- COVID-19 pandemic is a global disaster
- Pathophysiology is complex—not amenable to single drug
- The prehospital phase is the time of therapeutic opportunity
- Hospitalization and late treatment form an inadequate safety net with unacceptably high mortality





## Conclusions of McCullough Reports - 2

- Early ambulatory therapy with a sequenced, multi-drug regimen is supported by available sources of evidence and has a positive benefit-to-risk profile
  - Reduce the risk of hospitalization and death
  - More safely temporize to close the crisis with vaccination and natural herd immunity
- COVID-19 genetic vaccines have an unfavorable safety profile and are not clinically effective, thus they cannot be generally supported in clinical practice at this time
- Censorship and reprisal are working to crush freedom of speech, scientific discourse, and medical progress



# The COVID Shots Are Killing People

- Those at highest risk of dying from COVID-19 are also at highest risk of dying from the COVID shot. The shots are also causing severe heart damage in younger people whose risk of dying from COVID is inconsequential
- While you only get at most six months' worth of protection from the COVID shot, each injection will cause damage for 15 months as your body continuously produces toxic spike protein
- The spike protein is responsible for COVID-19-related heart and vascular problems, and it has the same effect when produced by your own cells. It causes blood clots, myocarditis and pericarditis, strokes, heart attacks and neurological damage, just to name a few
- The safety signal is very clear, with 19,249 deaths having been reported to the U.S. Vaccine Adverse Events Reporting System as of November 19, 2021. Historically, drugs and vaccines are pulled off the market after about 50 suspected deaths

# Nuremberg Code (1948)

1. The **voluntary consent of the human subject** is absolutely essential.
2. The experiment should be such as to **yield fruitful results** for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and knowledge of the natural history of the disease or other problem under study that **the anticipated results will justify the performance of the experiment.**
4. The experiment should be so **conducted as to avoid all unnecessary physical and mental suffering and injury.**
5. **No experiment should be conducted where there is an a priori reason to believe that death or disability injury will occur;** except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The **degree of risk to be taken should never exceed** that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided **to protect the experimental subject** against even remote possibilities of injury, disability, or death.
8. The experiment should be conducted only by **scientifically qualified persons.**
9. During the course of the experiment **the human subject** should be at liberty to bring the experiment to **an end** if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.
10. During the course of the experiment the **scientist in charge must be prepared to terminate the experiment at any stage,** if he has probable cause to believe that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

Bill Gates funded Johns Hopkins University experiments that infected 100's of Guatemalans with sexually transmitted diseases for drug and vaccine testing.

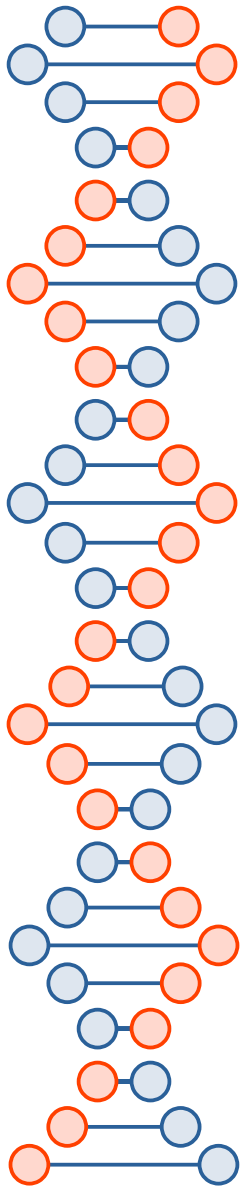
### 7. Genetically engineering our food with GMO's

# Winning the War Against Therapeutic Nihilism & Trusted Treatments vs Untested Novel Therapies

- COVID-19 pandemic is a global disaster
- Pathophysiology is complex—not amenable to single drug
- The prehospital phase is the time of therapeutic opportunity
- Hospitalization and late treatment form an inadequate safety net with unacceptably high mortality
- Early ambulatory therapy with a sequenced, multi-drug regimen is supported by available sources of evidence and has a positive benefit-to-risk profile
- Reduce the risk of hospitalization and death
- More safely temporize to close the crisis with vaccination and natural herd immunity
- COVID-19 genetic vaccines have an unfavorable safety profile and are not sufficiently effective, thus they cannot be generally supported in clinical practice at this time
- Censorship and reprisal are working to crush freedom of speech, scientific discourse, and medical progress





# False Narratives Overview – Steve Kirsch

- **False Narratives About Covid Jab Safety:**
  - The shots are safe and effective
  - No one has died from the COVID shot
  - You cannot use VAERS to determine causality

- 4 Equal risk of severe outcome if infected
- 5 No preventative or therapeutics available
- 6 We were not already partially immune; maybe as high as 80% (some level of immunity against SARS 2)

- 7 Social distancing of 6 feet prevents spread
- 8 Mass testing asymptomatic persons
- 9 Quarantine asymptomatic persons
- 10 Children spread the virus and at risk of severe illness
- 11 Masks are effective against viral illnesses
- 12 Natural immunity was inferior to vaccine-induced immunity and
- 13 Evolutionary pressure towards virulence is caused by unvaccinated people



# What We Do Know Today

- PCR tests don't work – too many false positives
- Cloth masks don't work
- Asymptomatic transmission is rare
- Natural immunity is better than vaccine immunity
- Covid-19 vaccines are still experimental
  - No animal testing
  - No long term testing
- The number of vaccine deaths and injuries is unacceptable
- VAERS numbers are 1% to 10% of the actual numbers
- Therapeutics (HCQ & Ivermectin) are safe and effective
- Lockdowns kill the economy

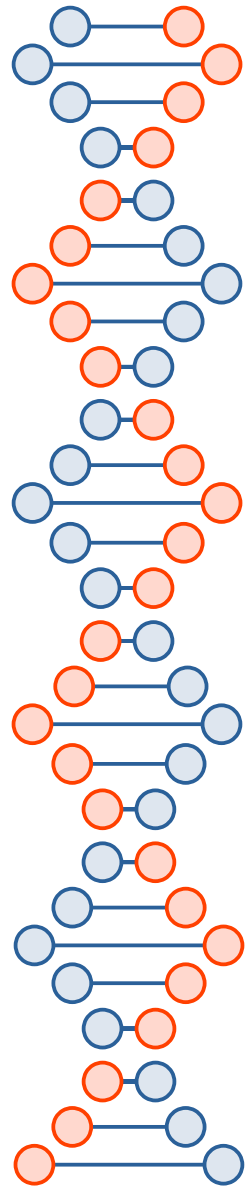

- Honor the Nuremburg Code



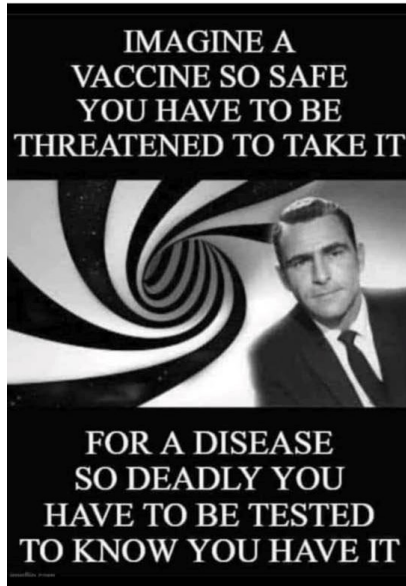

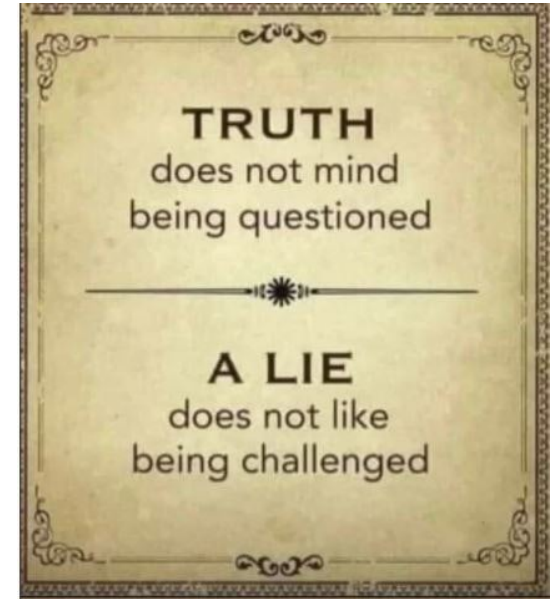
